PURPOSE AND EFFECT: The purpose and effect of this proposed rulemaking is to update Commission rules to reflect changes to the law, including changes made by chapters 2021-269 and 2024-115, Laws of Florida, and update the Commission's physical and website address.

SUMMARY: The proposed rulemaking amends Commission rules to implement the provisions of chapter 2024-115, Laws of Florida, update the commission's physical and website address, correct typographical errors, effectuate consistency between Commission rule chapters, and change all references from division to commission to reflect the type two transfer required by chapter 2021-269, Laws of Florida.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: based on the nature of the amendments to the rules, the Commission determined that the proposed rules are not expected to have any adverse impact on small business or increase regulatory costs that exceed the criteria in section 120.542(1) F.S., and that the proposed rules will not require legislative ratification.

- (1) Any permitholder authorized to submit an application for an annual license to conduct races or games pursuant to Section 550.0115, F.S., shall make such application to the commission division on Form FGCC PMW-Permitholder Application for Annual License and Operating Dates; http://www.flrules.org/Gateway/reference.asp?No=Ref-07666, either Form FGCC PMW-3105, Surety Bond for http://www.flrules.org/Gateway/reference.asp?No=Ref-07668, or provide Florida Pari-Mutuel Wagering. continuation certificate; Form **FGCC** PMW-3080. Permitholder Calendar; http://www.flrules.org/Gateway/reference.asp?No=Ref-07667, all of which are effective on December 13, 2016, and Form FGCC PMW-3190, Officers and Directors; http://www.flrules.org/Gateway/reference.asp?No=Ref-18583 97669, effective October, 2025 all of which are effective on 2016-12-13, and incorporated herein by reference. - (2) Any permitholder authorized to submit an application for an amendment to the annual license to conduct races or games pursuant to Section 550.01215, F.S., shall make such application to the <u>commission</u> division on Form FGCC PMW-3060, Permitholder Application for License and Operating Dates; Form FGCC PMW-3080, Permitholder Calendar; and Form FGCC PMW-3190, Officers and Directors; adopted by reference in subsection (1), above.

- (3) Once the annual operating license is issued, a minor amendment is an amendment to the license representing no more than 49 percent of the total performances from the current year's initial license. Adding or deleting the date of a scheduled performance will be calculated in the 49 percent maximum. If more than one amendment is requested on the same operating license, the requests will be aggregated to determine the 49 percent maximum.
- (4) Any request to amend racing dates submitted to the division shall include documentation from operating permitholders located within 50 miles of the applicant indicating whether they object to the issuance of an amended license.
- (5) Objections from operating permitholders must include an estimated fiscal impact with supporting data regarding impacts on handle and revenue.
