Supplemental Meeting Materials for 12/5/2024 for Item # 4.1.

I, Stephen Glen Kirby, am currently employed as a dual-rate manager at bestbet in Jacksonville. As a dual-rate manager, some days I will be a floor manager, and some days I will deal poker. I received my license to deal poker in Florida in August, 2023. Before that, I was a licensed poker dealer in Indiana for a year and a half. It was my employment at the Jacksonville bestbet that made me and my family move to Florida in 2023. I am 40 years old. I am a husband and father of two children, ages 21 and 20, both of whom live with my wife and I. My job at bestbet is my sole source of income, and is how I support myself and my family. Prior to the arrest and charges at issue in this case, I had never been arrested, criminally charged, or involved in any illegal activity.

This case involves two separate incidents that I would like to address. Both incidents involve charges of Petit Theft and I take full responsibility for my actions and decision to plead nolo contendere to each charge. However, the circumstances of each incident are very different.

The first incident occurred on October 17, 2023. The details of the incident are not in the police report or case file. In an effort to be completely open and honest with the Florida Gaming Control Commission, I will provide a full explanation of what occurred. While living in Indiana during COVID, I did some work for Uber to supplement my income. This was the first time I worked for Uber and I was not familiar with their payment system. I assumed that Uber withheld taxes from my pay like my other employers. However, Uber paid me as an independent contractor and did not withhold any taxes. As a result, I owed back taxes to the State of Indiana. I believe the state was unable to locate me due to my relocation to Florida. This resulted in the state getting a tax lien against me. I was not aware of this until my bank account was frozen sometime in mid-October 2023. While my account was frozen, my family ran out of food. I had \$20 cash so I went to Target to buy groceries for my family. I placed approximately \$20 worth of groceries in my bag and went to the self-checkout register. At that time, in a moment of desperation, I made a terrible mistake that was completely out of character. Instead of paying with the \$20 cash, I walked out of the store with the groceries without paying. I immediately regretted my decision.

The second incident occurred on November 30, 2023. I went to Target and checked out using the self-check-out register. At the register, I scanned and paid for about \$70 worth of items. On the bottom rack of my cart was about \$18 worth of drinks. I forgot I had these drinks below the cart, and as a result, I walked out without paying for them. Unlike the first incident, this was simply a mistake. I was not intending to take the drinks without paying. As I walked out of the store, I was approached by an officer and subsequently was arrested for Petit Theft. It appeared to me that there may have been some sort of sting operation occurring that day at Target and law enforcement was there to arrest individuals who may have been stealing from self-check-out registers. Apparently, Target's loss prevention agent identified me from the October 17th incident and wanted to press charges for both incidents. I understand why I was not given the benefit of the doubt with respect to this situation.

After I was arrested, I was placed in general population in the Duval County jail. I had never been arrested before, and had never been to jail. My experience while in jail was distressing, and the conditions inside the jail that I was held in were very poor. I was put in shackles and held in the same area as individuals accused of violent crimes such as murder. After my first night in jail, I was told by the Judge that if I pled guilty, I could be released that same day. I was so desperate to get out of jail as quickly and as safely as possible that I pled nolo contendere to the charges.

After I was released from jail, I immediately reported the incident to my shift manager at work. I was subsequently told not to say anything to anyone else, since "it was not a felony and no one would know about it." This was incorrect information, and the shift manager who told me this was eventually fired. It is my understanding that his statement to me to not report the incident was part of the reason he was let go. Due to this conversation with my shift manager, I did not notify the Florida Gaming Control Commission of my arrest or conviction. I now recognize that it is my responsibility as a cardroom licensee to report an arrest directly to the Florida Gaming Control Commission within 5 days and to report a conviction within 48 hours. I failed to do this and I sincerely apologize to the Florida Gaming Control Commission for my failure. I hope to never be in this situation again, but if for some reason I am, I will certainly report the incident as required.

I am hardworking member of the bestbet team and I greatly enjoy my job. Working in a cardroom is something I believe I am very good at and that I take seriously. I have had no reprimands during my employment with bestbet prior to this incident and I would never do anything to harm my employer. My job at bestbet is how I support my family. My wife also works at bestbet as a poker dealer, but can currently only work part-time. Before bestbet, I was a poker dealer in Indianapolis. I have also been licensed in Indiana for gaming and in Indiana and Tennessee for life insurance sales. I sold funeral insurance for 8 years and have been a poker dealer for about 3 years. In my close to 11 years of experience being licensed for various employments, I have never had any licensure issues at all prior to this incident. This is the first time in my life that I have been in significant trouble, and it has been something I hope to never experience again.

I fully understand that my license is subject to discipline. I take responsibility for my actions and accept the consequences that come along with those actions. I regret my actions and the impact it has had on my family and my employment. It is embarrassing and not the example I hope to set for my children. I am respectfully asking that the Commission consider the circumstances that lead to my pleas of nolo contendere, the absence of any prior misconduct, and the great effect a license revocation would have on mine and my family's life. Seeing how this event has jeopardized my livelihood and my ability to support my family has made me understand how much impact my actions outside of work can have. I deeply regret my actions and not notifying the Commission of my arrest. Though I had received bad information regarding whether or not to report it, I should have used my better judgement and informed

another supervisor of the incident or looked into the reporting requirements on my own. Again, I ask that the Commission show leniency and allow me to keep my license so that I can continue my employment with bestbet and can be able to consistently provide for my family.
