### **COMMISSIONERS**



### Julie Imanuel Brown, Vice Chairman

Julie Imanuel Brown was reappointed by Governor Ron DeSantis, on May 6, 2022, to serve as a Commissioner of the Florida Gaming Control Commission (FGCC). She previously served as the inaugural Chairman of the Florida Gaming Control Commission, initially appointed on December 21, 2021, until said reappointment. Brown brings substantial regulatory and legal experience from a number of significant roles in the public and private sectors.

Prior to her appointment, Brown was the Secretary of the Florida Department of Business and Professional Regulation where she led the state's regulation of more than 1.4 million licenses across more than 30 fields of industry. Brown led the Department in securing unanimous approval from the Florida Legislature in getting the Department's agency bill passed, which streamlined various licensing measures, and secured funding for the creation of a new licensing system. From 2011 to 2021, Brown served three terms as a Commissioner on the Florida Public Service Commission.

Brown was elected as Commission Chair from 2016 to 2018, and led the Commission's recommendations of electric utility storm-hardening actions following a period when Florida experienced major hurricane impacts for the first time in more than a decade, and she established initiatives to build and strengthen links between the Commission and its stakeholders with improvements in technology, communication, and quality of service. Before serving on the Commission, Brown was Associate Legal Counsel of First American Corporation where she handled a variety of regulatory compliance and legal issues in the Eastern, Midwest and Mid-Atlantic Regions. She also represented corporate clients with a specialized focus on matters involving mergers, acquisitions and securities, served as the Director of Franchise Sales and Development for Checkers Drive-In Restaurants, Inc., and was an Assistant City Attorney for the City of Tampa.

Brown has been involved with various professional and civic affiliations. She was appointed to serve as one of 11 Commissioners on the Florida Women's Suffrage Centennial Commission, chaired the Florida Legislature's 19-member Study Committee on Investor-Owned Water and Wastewater Utility Systems, was appointed to the Southern States Energy Board (SSEB) Blue Ribbon Task Force, and has served as a director on several utility boards, including the National Association of Regulatory Utility Commissioners, Gas Technology Institute's Advisory Board and the Nuclear Waste Strategy Coalition.

Brown graduated magna cum laude with a Bachelor of Science from the University of Florida, where she was the recipient of the Outstanding Female Leader award, President of Florida Blue Key, inducted into the Hall of Fame, and received the Dean's Cup for the College of Journalism and Communications. She earned a Juris Doctorate from the University of Florida, Levin College of Law, is a member of the Florida Bar, a Florida Real Estate Broker and a member of Leadership Florida, Class XXXIII. Brown and her husband have two children and live in Tampa, Florida.



### John D'Aquila, Commissioner

John D'Aquila has over 35 years of experience as a CPA, CFO, CEO, entrepreneur and consultant for entrepreneurs and emerging growth companies in diversified industries. He holds an active New York and Florida CPA license.

John started his career with the Ernst & Young Entrepreneurial Services Group in New York. He subsequently served as Chief Financial Officer and Vice President of Comstock Images overseeing expansion into five countries over nine years. He has founded a successful multistate retail business and has founded and managed a successful accounting services and tax preparation firm. He served eight years on the Board of Directors of the Binghamton University National Alumni Association during its first campaign. He had also served six years on the Board of Directors of the Northeast Florida Society of Financial Professionals. John served Sawgrass Country Club for many years as Vice Chairman of the Finance Committee.

He is a member of the New York State Society of CPA's, the American Institute of CPAs, and is a Chartered Global Management Accountant in addition to a CPA. He has been recognized by the French American Chamber of Commerce with a Corporate Achievement Award in connection with his role associated with building a successful USA business in France, Germany, Luxembourg, and the United Kingdom. John is a Voice of Democracy Scholarship Suffolk County winner and a recipient of the American Legion Citizenship award.

John earned his Bachelor of Science in Accounting at Binghamton University and became a Certified Public Accountant subsequently in both New York and Florida.



### Charles (Chuck) Drago, Commissioner

Chuck Drago is a former police chief with over 35 years of law enforcement experience. He served in the Fort Lauderdale Police Department for 29 years where he rose through the ranks from police officer to assistant chief of police. During his tenure, he served in many areas of the department including homicide, organized crime, vice and narcotics. In 2004, Chuck was appointed as the Chief of Police for the City of Oviedo where he was responsible for bringing community policing into the city.

As a Florida Certified Police Instructor, he has trained thousands of police officers from all over the country in use of force, undercover operations, criminal investigations, patrol procedures and domestic violence. Chuck has been a guest lecturer at colleges and universities on strategies for reducing officer involved shootings, biased-based policing, use of force, ethics and current trends in policing. He was instrumental in developing and teaching the first "Stalking Investigations" course for police officers in Florida.

Following a successful career as a law enforcement officer, Drago joined the Florida Department of Business and Professional Regulation (DBPR) as Deputy Secretary and Secretary. DBPR was the agency tasked with regulating the Pari Mutuel Wagering industry prior to the creation of the Florida Gaming Control Commission. Additionally, Drago also gained a great deal of knowledge into operations across agencies when he oversaw multiple state agencies including DBPR as a Deputy Chief of Staff in the Executive Office of the Governor.

After his time in Florida State Government, Chuck founded Drago Professional Consultants, advising police departments, law firms and media in proper police practices and policies. Drago has served as a certified expert witness in police practices throughout the country in state and federal courts.

Chuck earned an Associate Degree in Criminal Justice from the State University of New York, a Bachelor Degree in Criminal Justice from St. Thomas University (Miami) and is a graduate of the Southern Police Institute at The University of Louisville.

### Tina Repp, Commissioner

Tina Repp was appointed by Governor Ron DeSantis on April 28, 2023, to serve as a Commissioner of the Florida Gaming Control Commission (FGCC). Prior to her appointment, she was a Medicare fraud, waste and abuse investigator with Qlarant. She retired as a special agent from the Federal Bureau of Investigation in May of 2022, with more than 23 years of investigating Medicare fraud, complex financial crimes, government program frauds, elder fraud and transnational organized crime

As an FBI special agent, she received advanced training in anti-money laundering and international financial transactions. She was an FBI hostage/crisis negotiator and certified FBI legal advisor. Ms. Repp has worked closely with state and federal prosecutors, local and international law enforcement officers, and regulatory agencies to investigate and help prosecute criminals throughout the United States.

During her FBI career, she received numerous awards including the Tampa Region Financial Crimes and Inspector General Council Award for a Complex Financial Investigation, the Office of the Inspector General Exceptional Achievement Award for Medicare fraud, the U.S. Department of Justice Initiative Award, a Tampa Region Financial Crimes and Inspectors General Council Certificate of Achievement for a Joint Investigation, and a U.S. Office of Inspector General Exceptional Achievement Award for Medicare Fraud. She was recognized by the United States Attorney's Office, Middle District of Florida, as the 2017 Outstanding Law Enforcement Officer for Victim Crimes, 2016 for Economic Crimes, and in 2012 for Special Prosecutions.

Ms. Repp earned her Bachelor's Degree in Communications and International Relations from Baldwin Wallace University and her Juris Doctorate from Cleveland State University.

### COMMISSION OVERVIEW AND ORGANIZATION STRUCTURE

According to sections (s.) 16.712(1) and 550.0251(1), Florida Statutes (F.S.), the Florida Gaming Control Commission (FGCC) is statutorily required to create an annual report containing various information about the previous fiscal year's gaming activity which is made available to the public and distributed to key governmental entities. As is the usual course of business, this year's annual report contains statistical information about the fiscal year that began July 1, 2022, and ended June 30, 2023.

The Florida Gaming Control Commission is a five-member regulatory body that is responsible for exercising all regulatory and executive powers of the state with respect to gambling, including pari-mutuel wagering, cardrooms, slot machine facilities, oversight of gaming compacts, and other forms of gambling authorized by the State Constitution or law. On July 1, 2022, the FGCC assumed all statutory powers, including those matters currently within the scope of the jurisdiction of the Division of Pari-Mutuel Wagering. FGCC is also now the State Compliance Agency (SCA) pursuant to s. 285.710, F.S., responsible for monitoring compliance with the provisions of the Gaming Compact between the Seminole Tribe of Florida and the State of Florida.

In April of 2023, the Florida Senate unanimously confirmed Julie Imanuel Brown, John D'Aquila, and Charles (Chuck) Drago as Commissioners of the FGCC.

In April of 2023, Governor Ron DeSantis announced his appointment of Tina Repp as Commissioner to the FGCC.


### **Mission Statement**

### **Executive Direction and Support Services**

The Executive Direction and Support Services includes the Commission, executive leadership, general counsel, administration, and technology teams. Together, these service programs provide policy, direction, financial management, human resources. purchasing, records safety, loss and control and securities/property management, inspector general, legal, legislative, communications, information technology services, planning and budgeting, and mail services for the FGCC.

### The Division of Gaming Enforcement

The Division of Gaming Enforcement (DGE) is tasked with the dual mission of directly enforcing Florida's gambling laws and providing expert support to other law enforcement agencies in their efforts to combat illegal gambling activities.

Direct enforcement activities involve proactive investigations initiated by reports of illegal gambling, confidential sources, and investigative leads. Upon obtaining sufficient evidence, agents execute search warrants, resulting in arrests and the seizure of illegal gambling devices and contraband.

The DGE also serves as a valuable resource for state and local law enforcement partners, providing expert guidance on the intricacies of Florida's gambling laws and regulations. Agents share their knowledge and experience, assisting other law enforcement agencies in identifying illegal gambling activities, gathering evidence, and building strong cases for prosecution. This collaborative approach ensures that illegal gambling operations are effectively investigated and disrupted.

In August 2022, the Director of Law Enforcement was hired. The Director initiated the Florida Department of Law Enforcement (FDLE) hiring and training program. The DGE budget authorized 19 positions, that needed to be established, advertised, and employed. During the fiscal year, one Chief of Law Enforcement Section Leaders, and two administrative assistants were hired.

Two regional offices were established, one in North Florida and one in South Florida. The North Florida office was established in Tallahassee on July 1, 2022. The South Florida Regional Office space was acquired in Miami in June 2023.

### **Gaming Enforcement Investigations and Actions**

- During the 2022-2023 fiscal year, DGE received 1,266 total location based complaints of illegal gambling.
- From those complaints, 493 letters were sent to the local law enforcement departments informing them of possible illegal gambling activities at these locations.
- From those complaints, 506 letters were sent directly to businesses informing them of their possible participation in illegal gambling activities and providing copies of the gambling laws and associated criminal punishments.
- in DGE engaged in proactive outreach by actively participating conferences and fostering collaboration law enforcement with stakeholders. They established strong connections with cities and counties through effective communication channels, ensuring a cohesive approach to enforcing Florida's gambling laws.
- During the 2022-2023 fiscal year, DGE conducted joint investigation operations with the Chipley Police Department, Hillsborough Sheriff's Office, Holmes County Sheriff's Office, Manatee County Sheriff's Office, Palm Beach Sheriff's Office, St. Lucie County Sheriff's Office, and St. Petersburg Police Department resulting in 52 arrests and the seizure of:
  - o 858 illegal slot machines
  - o \$1,151,000 in cash
  - o \$2,000,000+ in real estate
  - o 40 grams of fentanyl
  - o 10 grams of methamphetamine

### The Division of Pari-Mutuel Wagering

The Division of Pari-Mutuel Wagering (DPMW) is charged with regulating licensed pari-mutuel, cardroom, and slot machine gaming industries, as authorized by Chapters 550, 551, and Section 849.086, Florida Statutes (F.S). Pari-Mutuel wagering was originally authorized by the Legislature in 1931. Pari-mutuel wagering is authorized for thoroughbred racing, harness horse racing, quarter horse racing, jai alai games, and simulcast greyhound racing. Cardrooms are authorized at licensed pari-mutuel facilities throughout Florida, and slot machine gaming at licensed pari-mutuel facilities in Broward and Miami-Dade counties.

DPMW's structure includes five functional areas which act under the management of the Office of the Director. These areas include Revenue and Financial Analysis, Auditing, Operations, Investigations, and Slot Operations. In its effort to maintain the integrity of authorized gaming in Florida and protect the welfare of the patrons and racing animals, DPMW maintains the following roles and responsibilities:

- Ensures individuals and businesses working or conducting business at a pari-mutuel facility must obtain an occupational license.
- Completes comprehensive reviews of pari-mutuel, cardroom, and slot annual operating licenses and associated amendment requests for approval or denial by the Commissioners.
- Monitors each horse race and conducts inquiries and hearings for alleged violations of the state's pari-mutuel statutes and rules.
- Collects urine, blood, and other samples from horses, which are sent to the racing laboratory for detection of impermissible substances or medications in accordance with the Horseracing Integrity and Safety Authority.
- Conducts compliance audits of pari-mutuel broadcast exchanges, interstate wagering restrictions, statutory and rule procedures, reported revenue amounts to their accounting transaction source documentation, oversight of the wagering pools, transmission of pari-mutuel information, proper calculations to winning pool wagers, and approval of totalizator security plans and software upgrades.
- Investigates patron complaints and alleged statutory or rule violations that occur at pari-mutuel facilities, cardrooms, and slot machine gaming areas. Investigators also perform in-depth background reviews of applicants with disqualifying criminal convictions who are requesting a waiver from the Executive Director in accordance with Section 550.105, F.S.
- Oversees day-to-day operations at the slot machine facilities, daily revenue reconciliations, verification slot machines have been certified by an independent testing laboratory, approval of slot machine shipments, and ensuring slot machine gaming activity meets or exceeds the minimum 85% payout threshold.
- Safeguards and accounts for state revenue, performs financial audits, develops revenue projections, maintains cash flow statements, compiles statistical information, and ensures for timely transfers of slot tax revenue to the Education Enhancement Trust Fund.
- Processes the annual cardroom county/municipality distribution in accordance with Section 849.086 (13), F.S.

In addition to the responsibilities above, the FGCC is designated by the Legislature as the State Compliance Agency to carry out the state's oversight responsibilities in accordance with the provisions outlined in the Compact between the State of Florida and the Seminole Tribe of Florida and process the annual local government distribution associated with the Compact as outlined in Section 285.710, F.S.<sup>1</sup>

### 2022/2023 DPMW REGULATORY/PERFORMANCE DATA

- Staff completed comprehensive reviews of 40 pari-mutuel wagering annual operating license applications, three non-wagering license applications, 29 annual cardroom license applications, and eight annual slot license applications.
  - As of December 1, 2023, the Division is currently reviewing three annual slot renewal license applications and one pari-mutuel amended operating license application.
- Licensing and operations staff processed 15,911 occupational license applications for businesses and individuals, of which 2,218 were related to cardroom operations, 10,848 were related to pari-mutuel operations, and 2,845 were related to slot machine operations. Fifty-four applications were denied.
- The Stewards and Hearing Officers issued 22 rulings and five consent orders with assessed fines and/or imposed license suspensions for violations.
- Auditors conducted 19 pari-mutuel compliance audits, 13 cardroom audits, eight slot audits, one breeders' and owners' awards audit, as well as 12 totalizator software upgrades and totalizator malfunction notifications submitted to the division.
- Investigated 248 pari-mutuel license waiver requests, complaints, and potential statute and/or rule violations related to pari-mutuel, cardroom, and slot activity. Investigators also conducted 1,530 facility visits and performed 667 pari-mutuel inspections to ensure statute and regulatory compliance.
- Slot operations staff performed 5,402 Slot inspections; of those, 71 items were found to be non-compliant, of which one was turned over to Investigations, and 56 facilities were notified of observations requiring internal action. Additionally, 505 shipments of authorized slot machines and components were approved, which required the verification of 677 slot machines and 5,277 slot machine components and monitored 9,441 slot machine conversions, denomination and/or game theme changes, slot machine relocations, and other related slot machine changes.
- Revenue staff reconciled 566 pari-mutuel, cardroom, and slot monthly remittance reports, conducted four charity day audits and 21 uniform annual report audits, and performed additional financial and statistical analysis of wagering activity.
- State veterinarians and veterinary assistants collected 8,315 horse urine and blood samples for submission to the racing lab for testing of impermissible substances and medication levels.
- The State Compliance Agency completed 73 inspections of tribal gaming facilities spanning over 730 staff hours.
- The Commission issued 218 Final Orders relating to regulatory oversight of the pari-mutuel permitholders, applicants, licensees, and other industry stakeholders as authorized by Chapters 550, 551, and Section 849.086, F.S.

### **ADOPTED RULES**

FGCC adopted a public comment rule, 75-15.001, effective September 25, 2023. The rule
invites and encourages all members of the public to provide comments on matters or
propositions before the Commission and the processes for comment.

### **RULES IN DEVELOPMENT**

 The FGCC has rules in development pertaining to Licensing Forms, Slot Machine Facility Cashless Wagering, and Greyhounds.

### EVENTS SHAPING THE 2022/2023 RACING/GAMING SEASON IN FLORIDA

- July 1, 2022 The Division of Pari-Mutuel Wagering was officially transferred from the Department of Business and Professional Regulation to the newly formed Florida Gaming Control Commission via a type two transfer.
- The Horseracing Integrity & Welfare Unit (HIWU) was established in 2022 by Drug Free Sport International (DFSI) to administer the rules and enforcement mechanisms of the Horseracing Integrity and Safety Authority's (HISA) Anti-Doping and Medication Control (ADMC) Program. HISA, through its Horseracing Integrity & Welfare Unit (HIWU) implemented the independent Anti-Doping and Medication Control (ADMC) enforcement agency, creating a centralized testing and results management process and applying uniform penalties for integrity violations. HIWU began overseeing the testing and adjudication of equine post-race and out-of-competition samples effective May 22, 2023.
- During the 2023 Legislative Session, Chapter 2023-157, L.O.F. (HB 7063) passed both the House and Senate chambers and was approved by the Governor. This bill became effective July 1, 2023. Chapter 2023-157, L.O.F. (HB 7063) created Section 550.09516, F.S., authorizing thoroughbred permitholders that conduct pari-mutuel wagering meets to be eligible for a credit equal to the amount paid by such permitholders in the prior state fiscal year to the federal Horseracing Integrity and Safety Authority (HISA), applicable to state taxes and fees and inclusive of any true-up calculations or credits made, granted, or applied to the assessment imposed on the permitholder or the state by HISA, for covered horse racing in the state, pursuant to the Horseracing Integrity and Safety Act of 2020. Additionally, Section 212.20, F.S., was amended, providing for \$27.5 million from the Sales and Use Tax to be distributed to the Florida Agricultural Promotional Campaign Trust Fund for further distribution in accordance with Section 571.265, F.S. Section 571.265, F.S., provides that the distributions shall be made annually among the Florida Thoroughbred Breeders' Association and the two thoroughbred racing tracks within Florida to encourage the agricultural activity of thoroughbred breeding and to enhance thoroughbred racing in Florida through June 30, 2025.
- September 29, 2022 Hurricane Ian made landfall on Florida's southwest coastline near Ft. Myers, crossing over the state exiting near Palm Coast, inflicting significant damage. Facility closures:

- November 3, 2022 The Commission approved the relocation of Fronton Holdings, LLC d/b/a Casino Fort Pierce, located at 1750 South Kings Highway, Fort Pierce, FL 34945, to 6666 South US Highway 1, Unit 2A, Port St. Lucie, FL 34952.
- November 10, 2022 Hurricane Nicole made landfall in Florida on the eastern coastline near Vero Beach.

### PENDING LITIGATION

### Debary Real Estate Holdings, LLC v. Florida Gaming Control Commission U.S. District Court Case number 4:23-CV-358-AW-MAF

In 2021, Debary Real Estate Holdings filed a complaint in the United States District Court, Northern District of Florida, seeking injunctive relief and a declaration that certain provisions of Chapter 21-271, Laws of Florida are unconstitutional or, in the alternative, a determination that the revocation of its permit is a taking that entitles Debary Real Estate Holdings to compensation for the same.

### Jefferson County Kennel Club, LLC v. Florida Gaming Control Commission Leon County Case number 2023-CA-002048

In 2021, Jefferson County Kennel Club filed a complaint in the Circuit Court of the Second Judicial Circuit, in and for Leon County, Florida, seeking injunctive relief in a declaration that certain provisions of chapter 21-271, Florida Laws, are unconstitutional or, in the alternative, a determination that the revocation of its permit is a taking that entitles Jefferson County Kennel Club just compensation for the same.

### Florida Gaming Control Commission v. Tampa Bay Downs Florida First District Court Case number 1D22-2802, DOAH Case No. 22-1121RU

Tampa Bay Downs, a thoroughbred permitholder conducting live race meets, challenged the Commission's position that, under Section 550.0951(3)(c)1, Tampa Bay Downs is not entitled to a reduced tax rate because it is not within a market area of another thoroughbred permitholder as an unadopted rule. The administrative law judge in DOAH Case No. 22-1121RU issued a final order that concluded, as a matter of law, that the Commission's position constituted an unadopted rule. The Commission appealed the Final Order at the First District Court of Appeal, which is currently pending.

### South Marion Real Estate Holdings, LLC d/b/a Oxford Downs and Darold R. Donnelly v. Florida Gaming Control Commission Florida Fifth District Court Case number 5D22-1477, DOAH case number 22-0968RX

Oxford Downs challenged Rule 61D-11.005(5) as an invalid rule. The administrative law judge in DOAH Case No. 22-0968RX issued a Final Order that concluded, as a matter of law, that the Commission has the requisite authority to promulgate Rule 61D-11.005(5) and that the Rule does not enlarge, modify, or contravene section 849.086, Florida Statutes. Oxford Downs appealed the Final Order at the Fifth District Court of Appeal, which is currently pending.

### Ramsey Zimmerman v. Florida Gaming Control Commission Florida Fifth District Court Case number 5D23-1062

Mr. Zimmerman, who has been convicted of disqualifying offenses in Florida, applied for an occupational license and a waiver from the restrictions excluding offenders. The director declined to waive the restrictions excluding offenders, and the Commission issued a letter of license denial to Mr. Zimmerman. Following an informal hearing by a Commission-appointed informal hearing officer, the Commission issued a Final Order denying Mr. Zimmerman's licensure application. Mr. Zimmerman appealed the Final Order at the Fifth District Court of Appeal, which is currently pending. The briefing has concluded, and oral argument occurred on November 29, 2023.

### West Flagler Association, Ltd, Bonita-Fort Myers Corporation d/b/a Bonita Springs Poker Room, and Isadore Havenick v. Ron DeSantis, Paul Renner, and Kathleen Passidomo Florida Supreme Court Case number SC2023-1333

On September 25, 2023, West Flagler Association, et al. filed a petition for writ of quo warranto with the Florida Supreme Court, alleging that the provisions of the 2021 Gaming Compact between the Seminole Tribe of Florida and the State of Florida, and the enactment of certain Florida statutes allowing the Seminole Tribe of Florida to conduct sports betting within its tribal lands and online, constitute an impermissible expansion of Article X, Section 30 of the Florida Constitution. The requested relief includes the suspension of online sports betting off tribal lands. On November 7, 2023, West Flagler Association, et al. filed a motion with the Court to expedite suspension of online sports betting off tribal lands, requesting the immediate suspension of the same. Litigation is ongoing.


## **Statistical Section**

#### CARDROOM COMPARATIVE DATA

During fiscal year 2022-2023, there were 29 permitholders that obtained a cardroom license. Of those, 26 operated at pari-mutuel facilities located throughout the state. The number of cardroom tables increased from 829 in fiscal year 2021/2022, to 911 in fiscal year 2022/2023. Table fees increased from \$829,000 to \$911,000 this fiscal year. Cardroom gross receipts increased from \$193,312,334 to \$217,168,480 and the gross receipts tax increased from \$19,331,234 to \$21,716,848 this fiscal year. The overall result was an increase in total state revenue from \$20,160,234 to \$22,627,848 this fiscal year.

Cardroom tax revenue is distributed 50 percent between the Pari-Mutuel Wagering Trust Fund and the General Revenue Fund. In accordance with Section 849.086(13)(h), Florida Statutes, one quarter of the moneys deposited into the Pari-Mutuel Wagering Trust Fund must be distributed to counties and municipalities that approved the cardroom. In October 2023, the Commission distributed approximately \$2,714,606 to the counties and municipalities from cardroom gross receipts taxes.



### **SLOT COMPARATIVE DATA**

During fiscal year 2022/2023, the total amount wagered by patrons was \$10,403,651,648 and total net slot revenue was \$691,398,142. As a result, the total taxes paid to the state was \$241,989,350, a less than one percent increase in total paid slot taxes from the previous state fiscal year. A total of \$20,250,000 was collected in annual slot license fees, including the Compulsive or Addictive Gambling Prevention Program Fee (CAGP), per Section 551.118(3), Florida Statutes.

### PARI-MUTUEL COMPARATIVE DATA

Beginning with the 1931/1932 fiscal year, the state began collecting taxes on pari-mutuel wagering. During that initial year, the pari-mutuel industry operated 462 racing days in Florida, which resulted in state revenue of \$737,301, total paid attendance of 1,157,161, and total pari-mutuel handle of \$17,365,424.

In most recent years, pari-mutuel handle has steadily declined. Since fiscal year 1931/1932, approximately \$78.6 billion in pari-mutuel handle wagered resulted in \$4.4 billion in state revenue. This fiscal year, the pari-mutuel industry operated 447 racing and gaming days, which resulted in state revenue of \$6,291,327, total paid attendance of 61,775, and total pari-mutuel handle of \$469,498,714. Of the pari-mutuel handle, greyhound permitholders accounted for 20.9 percent, jai-alai permitholders accounted for less than one percent, the harness permitholder accounted for 6.6 percent, and thoroughbred permitholders accounted for 72 percent. Four jai-alai permitholders and three thoroughbred permitholders conducted a combined 454 live performances this fiscal year.

Over the last 10 years, pari-mutuel wagering has experienced a 44.8 percent decline in handle, and total state revenue has decreased 54.4 percent, along with an 87.5 percent decrease in the number of racing and gaming days. Shown below is a summary of pari-mutuel handle and state revenue for fiscal years 2013/2014 through 2022/2023.

### **EXPLANATION OF REPORT TERMINOLOGY**

Pursuant to Section 550.002(13), Florida Statutes, handle is defined as the aggregate contributions to parimutuel pools. For purposes of this report, the four types of handle detailed in this report are as follows:

• Live On-track: Handle from live races/games at the track/fronton.

Simulcast: Handle from races/games originating from out-of-state and broadcast to a

Florida track/fronton.

Intertrack: Handle from where a Florida track/fronton (acting as host) broadcast live

races/games to other Florida tracks/frontons.

• Intertrack Simulcast: Handle from rebroadcasting of simulcast signals received by a Florida

track/fronton to other Florida tracks/frontons.

Florida law requires intertrack wagers to be combined with the wagering pools of the host or the broadcasting Florida track or fronton. The law also requires that the host take-out on intertrack wagers be the same as for ontrack wagers; however, the distribution of the take-out may be different. The tax structure for on-track and intertrack wagering is explained in more detail in the statute matrix section.

All intertrack and intertrack simulcast handle is detailed by the host permitholder in this report. These schedules reflect combined wagering statistics for all guest facilities that received broadcasts and conducted wagering that is included in the wagering pools of the host. Any paid attendance, admission tax, purses paid, or players' awards paid are detailed in the data by permitholder/facility section of the report.

Each permitholder may operate up to five additional days designated as charity or scholarship days during their regular meet. Pursuant to Section 550.0351, Florida Statutes, proceeds from these additional days are paid to approved charities, major state and private institutions of higher learning, community colleges, the Historical Resources Operating Trust Fund, and the Racing Scholarship Trust Fund (Board of Governors' Operations and Maintenance Trust Fund). A list of proposed recipients is submitted annually by the permitholder to the commission. A minimum of \$599,246 was paid to charitable organizations during fiscal year 2022/2023, bringing the total proceeds disbursed since 1985 to \$88,871,941.

### **ABANDONED WINNING TICKETS**

Abandoned pari-mutuel tickets are winning tickets that remain uncashed for a period of one year. The value of greyhound and jai alai abandoned tickets for live on-track races or games escheat to the state. These funds are deposited into the Department of Education's State School Trust Fund for the support and maintenance of Florida's public schools. Since 1957, the total paid into this fund is \$100,089,740. The amount collected from abandoned winning tickets for the State School Trust Fund for this fiscal year is detailed below.

In harness and quarter-horse racing, abandoned winning tickets are paid to the respective breeders' associations. Abandoned winning tickets from thoroughbred horse racing are retained by the permitholder.

### **MEDICATION AND SUBSTANCE VIOLATIONS**

During fiscal year 2022/2023, the racing laboratory received and processed 8,315 samples and performed 33,066 analyses. The vigilant monitoring of samples by the laboratory serves to deter the use of prohibited drugs in racing animals in Florida.

- Class (1): Stimulant and depressant drugs that have the highest potential to affect performance and that have no generally accepted medical use in the racing horse.
- Class (2): Drugs that have a high potential to affect performance, but less of a potential than drugs in Class I.
- Class (3): Drugs that may or may not have generally accepted medical use in the racing horse, but the pharmacology of which suggests less potential to affect performance than drugs in Class 2.
- Class (4): This class includes therapeutic medications that would be expected to have less potential to affect performance than those in Class 3.
- Class (5): This class includes therapeutic medications for which concentration limits have been established by the racing jurisdictions as determined by the regulatory bodies.

The Horseracing Integrity and Safety Authority (HISA) took over the responsibility of drug testing on May 22, 2023.

### Promotional Programs for Florida-Bred Horses \*


Florida breeder promotions and award programs are administered by private breeders' and owners' associations organized to promote ownership and breeding of race horses in the State of Florida. Each association conducts its own campaign to enhance the horse breeding industry in the state and provides breeders' and owners' awards of up to 20 percent of announced gross purses. The Florida Standardbred Breeders' and Owners' Association is funded by the breaks and uncashed tickets from live performances and one percent of the intertrack handle. The Quarter Horse Breeders' Association is funded by the breaks and the uncashed tickets from live races and one percent of the live and intertrack handle. The Florida Thoroughbred Breeders' and Owners' Association awards program is funded by 0.955 percent of the live, simulcast, and intertrack handle, as well as 3.475 percent of the gross revenue from out-of-state wagers on Florida races.


To date, the Florida thoroughbred breeding industry has produced 52 national champions. Florida also produced "Affirmed", the 11th horse to have swept the Triple Crown (1978). Ocala/Marion County, Florida, is home to some of the leading breeding farms in the country. The industry boasts 20 classic wins (Kentucky Derby, Preakness Stakes, and Belmont Stakes), 30 Breeders' Cup Day champions and six horses of the year.

The Florida Thoroughbred Breeders' and Owners' Association (FTBOA) funds the Florida-bred Stakes Program, which is implemented at Florida's Thoroughbred racetracks. Through a percentage of pari-mutuel handle, Florida Thoroughbred permitholders contributed \$7,193,347 to the FTBOA during fiscal year 2022/2023. The FTBOA paid out \$4,865,456 in Breeders' Awards and \$1,834,380 through the Florida-bred Stakes Program. The Florida-bred Stakes Program includes "Florida Sire Stakes" at Gulfstream Park, "Florida Cup Day" at Gulfstream Park, and "Florida Sire Stakes" at Tampa Bay Downs, and additional funds for supplements to Florida-bred Preferred Stakes Races during the Gulfstream and Tampa Bay Downs' meets.




### HISTORICAL PARI-MUTUEL WAGERING ACTIVITY

# Appendix

### Revenue Estimating Conference Indian Gaming Revenues Executive Summary February 14, 2023

The Revenue Estimating Conference met on February 14, 2023, to adopt new estimates for Indian Gaming revenues. The Governor and the Seminole Tribe of Florida signed a new Compact on April 23, 2021, with an amendment on May 17, 2021. It was subsequently ratified by the Legislature in Special Session by CS/SB 2-A, which was approved by the Governor on May 25, 2021. The State of Florida began receiving Indian Gaming payments pursuant to the new Compact in October of 2021. The U.S. District Court for the District of Columbia set aside federal approval of the 2021 Compact on November 22, 2021. The Seminole Tribe of Florida continued revenue sharing with the State of Florida through February, 2022, after which time they discontinued all payments. Between October 2021 and February 2022, the state received 5 payments of \$37.5 million, totaling \$187.5 million.

The case is under appeal in the United States Court of Appeals for the D.C. Circuit. Oral arguments were held on December 14, 2022. It is currently unknown when or if payments from the Seminole Tribe of Florida will resume into state accounts. Therefore, the Conference maintained the current General Revenue estimate with the current FY 2022-23 and all out years at zero.
