

OVERVIEW

This annual report encompasses the fiscal year which began July 1, 2020, and ended June 30, 2021. This is the 90th annual report in the series. The first annual report was issued for Fiscal Year 1931/1932, the initial year of legalized pari-mutuel wagering. This annual report, which is required by Florida law, is intended to inform the Governor, the Legislature, the industry, and other interested parties of wagering activities at authorized pari-mutuel facilities. The report is organized into five primary sections:

1. **Introductory Section** – An overview of the Division of Pari-Mutuel Wagering and a report of events that occurred impacting the division's oversight of permits, licenses, or events that affected the operation of such facilities.
2. **Data by Permitholder/Facility** – Includes operating information by association/permit, promotional programs for Florida-bred horses, and impermissible substance positives statistical data.
3. **Statistical Section** – Details various cardroom, pari-mutuel, and slot statistical data by individual racing association or fronton.
4. **Financial Section** – Official financial statements of the Division of Pari-Mutuel Wagering.
5. **Statute Matrix** – A table that summarizes the statutes regarding the taxes and fees applicable to pari-mutuel wagering and cardroom activity. The matrix includes a summary of the statutes regarding the taxes, fees, fines, and penalties with respect to slot machine gaming.

THE DIVISION OF PARI-MUTUEL WAGERING

The Division of Pari-Mutuel Wagering is a program area of the Department of Business and Professional Regulation within the Executive Branch of Florida's government. The division is charged with regulating Florida's pari-mutuel, cardroom, and slot machine gaming industries, as authorized by Chapters 550, 551, and Section 849.086, Florida Statutes, as well as collecting and safeguarding associated revenues due to the state. Authorized pari-mutuel events include harness racing, quarter horse racing, thoroughbred racing, greyhound racing, and jai alai. Pari-Mutuel Wagering was originally authorized by the Legislature in 1931. In Florida, pari-mutuel wagering is authorized for horse racing, harness horse racing, quarter horse racing, greyhound racing, jai alai games, and cardroom poker games. Additionally, slot machine gaming at pari-mutuel facilities is authorized in Broward and Miami-Dade counties. Florida is one of the primary pari-mutuel states in the nation. Florida is also the only state in the United States where live jai alai games are conducted.

Since that time, the division has evolved from a racing commission into a professional regulatory organization overseeing a complex and dynamic industry located throughout the state. Additionally, the Division of Pari-Mutuel Wagering was designated by the Florida Legislature as the State Compliance Agency with the authority to carry out the state's oversight responsibilities in accordance with the provisions outlined in the Compact between the State of Florida and the Seminole Tribe of Florida.

OFFICE OF THE DIRECTOR

The Office of the Director provides leadership, oversight, and administration of the six functional areas within the division. Specific responsibilities include budget planning, rule promulgation, policy development, analyses of proposed legislation, strategic planning, fleet management, staff development, and enforcement of administrative actions. Additionally, the Office of the Director ensures that all areas of the division operate in a cooperative effort to provide efficient regulatory oversight of the industry.

The division's structure includes six functional areas which act under the management of the Office of the Director. These functional areas include Revenue and Financial Analysis, Auditing, Operations, Investigations, Slot Operations, and The State Compliance Agency. Each area focuses on a different aspect of regulation within the cardroom, pari-mutuel, and slot machine gaming industry, as well as the state's Compact with the Seminole Tribe of Florida, in an effort to protect state revenues and maintain the public's confidence in the integrity of the wagering activity. Additionally, the Office of the Director processes applications for the issuance of all pari-mutuel permitholder Annual Operating Dates Licenses, Cardroom Operating Licenses, and Slot Machine Licenses to authorized facilities.

OFFICE OF OPERATIONS

All individuals and businesses who work or conduct business at a pari-mutuel facility and who have access to wagering activity, restricted areas, cardroom, slot floor, and/or racing animals, must obtain an occupational license issued by the division. Every occupational licensee is fingerprinted upon initial licensure and every three years thereafter and they are submitted electronically to the Florida Department of Law Enforcement and the Federal Bureau of Investigation for processing. During Fiscal Year 2020/2021, the Operations' Licensing Section processed 15,553 occupational license applications for businesses and individuals, of which 2,767 were related to cardroom operations, 9,822 were related to racing operations, and 2,964 were related to slot machine operations.

The Office of Operations is also responsible for ensuring that the day-to-day operation of races and games are conducted in accordance with Florida's pari-mutuel statutes and rules. The State Stewards monitor each horse race and conduct inquiries and hearings for alleged violations of the state's pari-mutuel statutes and rules. The Stewards and Hearing Officers issued 25 rulings and 5 consent orders, assessed fines totaling \$3,300 and imposed no license suspensions for violations during Fiscal Year 2020/2021.

Operations' staff collects urine and blood samples from racing animals which are sent to the University of Florida, College of Medicine Racing Laboratory for analysis. The Racing Laboratory performs its services under an annual contract with the division. State veterinarians and veterinary assistants collected 14,459 samples that included 5,272 greyhound urine samples and 9,187 horse urine and blood samples during Fiscal Year 2020/2021. There were 90 positive findings of impermissible substances in the samples collected.

OFFICE OF AUDITING

The Office of Auditing is responsible for conducting various audits to ensure the integrity of wagering activity and protect the wagering public by assuring that cardroom, pari-mutuel, and slot machine wagering is conducted in compliance with the Florida Statutes and Florida Administrative Code. Such compliance issues include pari-mutuel broadcast exchanges, verification that takeout/commissions are consistent with notification requirements, interstate wagering restrictions, verification that statutory and rule procedures are followed, tracing reported revenue amounts to their accounting transaction source documentation, oversight of the wagering pools, transmission of pari-mutuel information, proper payments to winning pari-mutuel patrons, and approval of totalisator security plans and software upgrades. Additionally, the auditing staff maintains primary oversight for cardroom operations, which includes: auditing internal control procedures, auditing jackpot accounts, monitoring daily operations, and auditing for compliance. Audits of malfunction reports were also conducted. The auditing team is responsible for communicating with the licensed totalisator companies and for the input of pari-mutuel handle and wagering information into the division's Central Management System.

During the 2020/2021 audit cycle, the Auditing staff conducted 13 greyhound purse audits, 19 greyhound adoption audits, 32 compliance audits, 23 escheat audits, 24 cardroom audits, and eight slot audits.

OFFICE OF INVESTIGATIONS

The Office of Investigations examines statutory and rule violations that occur at pari-mutuel facilities to include: cardrooms, and slot machine gaming areas. Reports of these violations can originate from division investigators, concerned citizens, law enforcement sources or the pari-mutuel facilities themselves. Alleged violations can involve cheating during a gaming activity, employee theft, as well as disruptive or threatening behavior while on the grounds of a permit holder. Investigations of this type typically lead to a lifetime exclusion of the offender from the concerned facility, and may also result in criminal prosecution and/or a statewide exclusion from all pari-mutuel facilities in the state.

The Office of Investigation is also responsible for investigating a variety of racing related violations. The nature of these investigations include Class I drug positives analyzed and identified by the University of Florida; College of Medicine Racing Laboratory; patron complaints, allegations of animal cruelty, the use of performance altering medications, and illegal substances during races.

An investigation may result in the issuance of a warning letter, consent order, administrative fine, license suspension, or a hearing before an Administrative Law Judge. Investigations may also lead to referral to other regulatory agencies or law enforcement organizations for criminal prosecution. During Fiscal Year 2020/2021, there were 379 investigations conducted. Investigators also perform in-depth background reviews of Pari-Mutuel Wagering Occupational License requests from applicants with disqualifying criminal convictions who are requesting a waiver from the Division Director in accordance with Section 550.105, Florida Statutes. The Investigation staff also conducted 2,289 inspections of pari-mutuel facilities, including cardrooms, slots, greyhound kennels and horse stables throughout the operating year. During Fiscal Year 2020/2021, as greyhound racing was being phased out in Florida, the Office of Investigations closely monitored the process at each greyhound facility to ensure a safe and orderly transition of all greyhounds.

OFFICE OF SLOT OPERATIONS

The Office of Slot Operations is responsible for overseeing state personnel located at the four pari-mutuel facilities in Broward County and four pari-mutuel facilities in Miami-Dade County that have slot machine gaming. To protect the integrity of slot machine gaming activity, the Slot Operations' staff oversees the day-to-day operations at the slot machine facilities, performs daily revenue reconciliations, verifies that every slot machine has been certified by an independent testing laboratory, issues slot machine occupational licenses to individuals, and ensures slot machine gaming activity is in compliance with the requirements of Chapter 551, Florida Statutes, Chapter 61D-14, Florida Administrative Code, as well as the internal controls of the individual facilities.

During Fiscal Year 2020/2021, the Slot Operations' staff completed 3,266 inspections. Of those, 48 items were found to be non-compliant, of which one was turned over to Investigations and three to the Department's Office of the General Counsel for formal proceedings. Slot machine facilities were notified of 42 observations so that appropriate internal action, including employee disciplinary action, advanced training and/or re-training of facility personnel could occur.

There were 223 shipments of authorized slot machines and components, which required the verification of 407 slot machines and 2,785 components. The Slot Operations' staff authorized and monitored 7,792 slot machine conversions, denomination and/or game theme changes, slot machine relocations and other related slot machine changes.

OFFICE OF REVENUE AND FINANCIAL ANALYSIS

The Office of Revenue and Financial Analysis is responsible for safeguarding and accounting for state revenues in accordance with Florida Statutes and the Florida Administrative Code, as it relates to cardroom, pari-mutuel, and slot gaming activities. The staff develops revenue projections for the Revenue Estimating Conferences, maintains cash flow statements for timely transfer to the State's General Revenue Fund and to the Education Enhancement Trust Fund, provides oversight of the division's Central Management System, develops the division annual report, deposits fines and miscellaneous revenue, performs analysis of proposed legislation, and determines fiscal impacts on proposed legislation impacting the industry.

During Fiscal Year 2020/2021, \$220,432,388 in state revenues pertaining to cardroom, pari-mutuel, and slot machine gaming were collected. The Revenue and Financial Analysis staff also reconciled 624 permitholder pari-mutuel, cardroom, and slot monthly remittance reports, conducted 13 charity day audits and 21 uniform annual report audits. The Revenue and Financial Analysis staff compiles statistical information for cardroom, pari-mutuel, and slot machine gaming, and performs revenue analyses requested by the department, the Executive Office of the Governor, the Legislature and the industry.

STATE COMPLIANCE AGENCY

The Gaming Compact between the Seminole Tribe of Florida and the State of Florida, 75 FR 38833, was executed by the Governor on April 7, 2010, and ratified by the United States Department of the Interior on July 7, 2010. Pursuant to Section 285.710, Florida Statutes, the Division of Pari-Mutuel Wagering was designated by the Florida Legislature as the State Compliance Agency with the authority to carry out the State's oversight responsibilities in accordance with the provisions outlined in the Compact. The Seminole Tribe of Florida presently operate six casinos, with authority for seven, located in Broward, Hillsborough, Collier, Glades, and Hendry counties.

During Fiscal Year 2020/2021, the State Compliance Agency completed 18 inspections of tribal gaming facilities spanning over 180 man-hours. There were no payments made by the Tribe after April 2019, for the 2010 Compact, therefore, during Fiscal Year 2020/2021 no distribution was made to the local government, including both counties and municipalities,

EVENTS SHAPING THE 2020/2021 RACING/GAMING SEASON IN FLORIDA

- Beginning in March 2020 through August 2020, many Florida pari-mutuel facilities suspended or reduced live events, cardroom operations, and slot gaming due to the COVID-19 pandemic. As a result, many permitholders' annual wagering activity and associated state revenue was significantly lower than in prior state fiscal years.
- All greyhound permitholders ceased operation of live greyhound races on or before January 1, 2021, in accordance with Article X, Section 32 of the Florida Constitution.
- On April 23, 2021, as amended on May 17, 2021, a new Gaming Compact was signed by the Governor and the Seminole Tribe of Florida.
- During the 2021 Legislative Special Session A, several bills (ENR CS/SB 2-A, ENR CS/SB 4-A, ENR SB 6-A, and ENR SB 8-A) passed both the House and Senate chambers and were approved by the Governor amending the industry's governing chs. 550, 551, and s. 849.086, Florida Statutes, (F.S.). Additionally, during the Special Session, the Legislature ratified the gaming compact between the State of Florida and the Seminole Tribe of Florida.
 - ENR CS/SB 2-A
Implementation of the 2021 Gaming Compact Between the Seminole Tribe of Florida and the State of Florida; provided for legislative approval and ratification of a gaming compact between the Seminole Tribe of Florida and the state; required the Governor to cooperate with the Tribe in seeking approval and ratification of such compact from the United States Secretary of the Interior; authorized the Tribe to conduct additional games, contests, and sports betting; provided age requirements for sports betting; provided conditions, requirements, and prohibitions relating to poker games played in a designated player manner.
 - ENR CS/SB 4-A
Created the Florida Gaming Control Commission with the Department of Legal Affairs, Office of the Attorney General; provides requirements for members of the commission; requires the Commission on Ethics to accept and investigate any alleged violations of the standards of conduct for commissioners; designates the Florida Gaming Control Commission as the state compliance agency having authority to carry out certain responsibilities; transfers all powers, duties, functions, records, offices, personnel, property, pending issues, existing contracts, administrative authority, administrative rules, trust funds, and unexpended balances of appropriates, allocations, and other funds of the Department of Business and Professional Regulation (DBPR) related to the oversight of the gaming compacts under s. 285.710, F.S., and the regulation of chs. 550, 551, and s. 849.086, F.S., to the commission by a type-two transfer.
 - ENR SB 6-A
Provides that the Florida Gaming Control Commission ("Gaming Commission") would conduct public meetings and specifies that certain matters heard or addressed at these public meetings would be confidential and exempt from chs. 119 and 286, F.S., and s. 24(a), Article I of the State Constitution. This exemption is subject to the Open Government Sunset Review Act and will repeal on October 2, 2026, unless otherwise reviewed and reactivated by the Legislature.
 - ENR SB 8-A
Revised the requirements for certain permitholders to conduct live racing or games. Provided for technical drafting changes, conforming changes, and eliminated obsolete language related to such requirements for live racing or games. In addition, it provided that no additional permits may be issued and that a pari-mutuel permitholder may not be issued

an operating license for the conduct of pari-mutuel wagering, slot machine gaming, or a cardroom if the permitholder did not hold an operating license in Fiscal Year 2020-2021.

These bills establish an effective date on the same date the compact takes effect upon federal approval by action of the U.S. Secretary of Interior or by operation of law under 25 U.S.C. s. 2710(d)(8) upon publication of the notice of federal approval in the Federal Register. During the preparation of this annual report and subsequent to Fiscal Year 2020-2021, on August 11, 2021, such notice was published in the Federal Register.

- In November 2019, the Division of Pari-Mutuel Wagering initiated rulemaking regarding numerous rules related to licensing within 61D-5.001-5.004, 61D-11.001, 61D-11.008-11.0101, 61D-14.002, 61D-14.005-14.006, and 61D-14.008-14.012, F.A.C. Those rules became effective September 1, 2020.
- In May 20, 2021, the Division filed Emergency rule 61DER21-3 to supersede and replace Emergency rule 61DER21-2 that was filed on March 4, 2021. The rule prescribes the testing methodologies and measurement of uncertainties applicable to the testing of biological specimens sent to the University of Florida Racing Laboratory for analysis as well as clarifying when these testing methodologies and measurement of uncertainties apply. The rule became effective August 4, 2021.
- On September 15, 2020, Hurricane Sally hit the Florida Panhandle, resulting in facilities located in that area to close for the day.
- Hurricane Eta hit the southern part of Florida, resulting in some facility closures during the first week of November 2020.

HORSE RACING

Promotional Programs for Florida-Bred Horses *

Florida breeder promotions and award programs are administered by private breeders' and owners' associations organized to promote ownership and breeding of race horses in the State of Florida. Each association conducts its own campaign to enhance the horse breeding industry in the state and provides breeders' and owners' awards of up to 20 percent of announced gross purses. The Florida Standardbred Breeders' and Owners' Association is funded by the breaks and uncashed tickets from live performances and one percent of the intertrack handle. The Quarter Horse Breeders' Association is funded by the breaks and the uncashed tickets from live races and one percent of the live and intertrack handle. The Florida Thoroughbred Breeders' and Owners' Association awards program is funded by 0.955 percent of the live, simulcast, and intertrack handle, as well as 3.475 percent of the gross revenue from out-of-state wagers on Florida races.

To date, the Florida thoroughbred breeding industry has produced 50 national champions. Florida also produced "Affirmed", the eleventh horse to have swept the Triple Crown (1978). Ocala/Marion County, Florida, is home to some of the leading breeding farms in the country. The industry boasts 20 classic wins (Kentucky Derby, Preakness Stakes, and Belmont Stakes), 28 Breeders' Cup Day champions and six horses of the year.

The Florida Thoroughbred Breeders' and Owners' Association (FTBOA) funds the Florida-bred Stakes Program, which is implemented at Florida's Thoroughbred racetracks. Through a percentage of pari-mutuel handle, Florida Thoroughbred permitholders contributed \$7,636,636 to the FTBOA during Fiscal Year 2020/2021. The FTBOA paid out \$4,110,869 in Breeders' Awards and \$1,787,550 through the Florida-bred Stakes Program. The Florida-bred Stakes Program includes "Florida Sire Stakes" at Gulfstream Park, "Sunshine Preview" at Gulfstream Park West, "Florida Cup Day" and "Florida Sire Stakes" at Tampa Bay Downs, and additional funds for supplements to Florida-bred Preferred Stakes Races during the Gulfstream and Tampa Bay Downs' meets.

The Florida Standardbred Breeders' and Owners' Association (FSBOA), a non-profit organization and the only organized representative of the Standardbred horsemen in the State of Florida, is the designated association for the allocation and distribution of funds for Florida-bred racing. Promotional activities include providing breeder and stallion awards for eligible Florida-bred horses during Pompano Park's 2020/2021 meet, as well as awards for Florida Breeders' Stake races. The FSBOA inaugurated a breeder-incentive program in 2012, which continued in 2021, with the goal of offering Standardbred breeders a financial reward for the production of Florida-sired foals. The program benefits Standardbred Breeders in Florida stakes races. Awards are provided for two-year old and three-year-old Florida Standardbreds. Despite the challenges of COVID-19, during the past season, the Standardbred Breeders' and Owners' sponsored stake races provided awards and purse money to the Florida Standardbred horsemen in excess of \$898,000 during 2020/2021 meet. Additionally, the program continued to reward Florida Standardbred breeding farm participants with more than \$83,000. Over the past decade, the program has injected more than \$10 million dollars of support to Breeders, Horsemen/women, and farmers throughout the State of Florida.

**UNIVERSITY OF FLORIDA
COLLEGE OF VETERINARY MEDICINE RACING LABORATORY**

The Florida Racing Laboratory in the College of Medicine at the University of Florida is an ISO 17025-2017 and RMTC accredited laboratory that employs various procedures to detect and identify prohibited drugs, medications, stimulants, depressants, hypnotics, local anesthetics, and drug masking agents in the blood, urine or other bodily fluids of racing horses and greyhounds.

During Fiscal Year 2020/2021, the Laboratory received and processed 14,459 samples and performed 63,423 analyses. The vigilant monitoring of samples by the Laboratory serves to deter the use of prohibited drugs in racing animals in Florida.

Class (1): Stimulant and depressant drugs that have the highest potential to affect performance and that have no generally accepted medical use in the racing horse.

Class (2): Drugs that have a high potential to affect performance, but less of a potential than drugs in Class 1.

Class (3): Drugs that may or may not have generally accepted medical use in the racing horse, but the pharmacology of which suggests less potential to affect performance than drugs in Class 2.

Class (4): This class includes therapeutic medications that would be expected to have less potential to affect performance than those in Class 3.

Class (5): This class includes therapeutic medications for which concentration limits have been established by the racing jurisdictions as well as certain miscellaneous agents such as dimethylsulfoxide (DMSO) and other medications as determined by the regulatory bodies.

FISCAL YEARS COMPARATIVE DATA

Beginning with the 1931/1932 Fiscal Year, the state began collecting taxes on pari-mutuel wagering. During that initial year, the pari-mutuel industry operated 462 racing days in Florida, which resulted in state revenue of \$737,301, total paid attendance of 1,157,161, and total pari-mutuel handle of \$17,365,424.

In most recent years, pari-mutuel handle has steadily declined. Since Fiscal Year 1931/1932, approximately \$77.7 billion in pari-mutuel handle wagered resulted in \$4.4 billion in state revenue. This fiscal year, the pari-mutuel industry operated 1,288 racing and jai-alai days, which resulted in state revenue of \$7,224,825, total paid attendance of 35,861, and total pari-mutuel handle of \$449,239,685.

Over the last 10 years, pari-mutuel wagering has experienced a 48.7 percent decline in handle, and total state revenue has decreased 47.7 percent, along with a 64.2 percent decrease in the number of racing days. Shown below is a summary of pari-mutuel handle and state revenue for Fiscal Years 2011/2012 through 2020/2021.

EXPLANATION OF REPORT TERMINOLOGY

Pursuant to Section 550.002(13), Florida Statutes, handle is defined as the aggregate contributions to pari-mutuel pools. For purposes of this report, the four types of handle detailed in this report are as follows:

- **Live On-track:** Handle from live races/games at the track/fronton.
- **Simulcast:** Handle from races/games originating from out-of-state and broadcast to a Florida track/fronton.
- **Intertrack:** Handle from where a Florida track/fronton (acting as host) broadcast live races/games to other Florida tracks/frontons.
- **Intertrack Simulcast:** Handle from rebroadcasting of simulcast signals received by a Florida track/fronton to other Florida tracks/frontons.

Florida law requires intertrack wagers to be combined with the wagering pools of the host or the broadcasting Florida track or fronton. The law also requires that the host take-out on intertrack wagers be the same as for on-track wagers; however, the distribution of the take-out may be different. The tax structure for on-track and intertrack wagering is explained in more detail in the statute matrix section.



All intertrack and intertrack simulcast handle is detailed by the host permitholder in this report. These schedules reflect combined wagering statistics for all guest facilities that received broadcasts and conducted wagering that is included in the wagering pools of the host. For host permitholders, a summary of intertrack handle components for each guest is shown in the statistical section of this report. The schedules of intertrack wagering handle by guest include data on wagers from intertrack handle and intertrack simulcast handle. Any paid attendance, admission tax, purses paid, or players' awards paid are detailed in the data by permitholder/facility section of the report.





HISTORICAL PARI-MUTUEL WAGERING ACTIVITY

GREYHOUND PERMITHOLDERS



Florida has 19 greyhound permitholders, six of them operated live performances at three tracks throughout the state. A total of 573 completed performances, including charity and scholarship performances, were conducted during this past fiscal year, a decrease of approximately 68 percent from the previous year.

During Fiscal Year 2020/2021, handle wagered on live greyhound performances decreased by approximately 60 percent. Intertrack handle wagered on broadcasts of live Florida greyhound performances decreased by approximately 52 percent. Simulcast handle wagered on broadcasts of performances from outside the state increased by approximately 109 percent. Intertrack simulcast handle wagered on broadcast of performances from outside the state increased by approximately 204 percent. Overall, there was a decrease in total handle by approximately 11 percent for the Florida greyhound industry.

There was no paid attendance for greyhound permitholders in Fiscal Year 2020/2021. The division reports only paid attendance and does not include free admissions or complimentary passes in its data. Total greyhound revenue to the state decreased by approximately one percent during Fiscal Year 2020/2021. The greyhound industry accounted for approximately seven percent of Florida's total pari-mutuel revenue and 27.04 percent of total handle from pari-mutuel performances.

Greyhound permitholders reported paying a total of \$5,471,354 in purses during Fiscal Year 2020/2021. For more detail on purses paid, please refer to pages eight and nine of this annual report. The division was able to confirm reported purse amounts from the weekly purse reports submitted in accordance with Rule 61D-8.006, Florida Administrative Code.

All of Florida's greyhound permitholders actively sponsor greyhound adoption programs. Many of the state's greyhound tracks provide for on-site adoption booths, animal welfare, funding, advertising, special events and public information. Section 550.1647, Florida Statutes, provides a greyhound permitholder with credits in an amount equal to the uncashed pari-mutuel tickets remitted in the prior state fiscal year to the state, which is applied against any taxes imposed the next fiscal year. Additionally, Section 550.1647, Florida Statutes, requires each permitholder to pay an amount not less than 10 percent of the credit provided by this section to any bona fide organization that promotes or encourages the adoption of greyhounds. During Fiscal Year 2020/2021, total contributions provided to greyhound adoption units amounted to \$66,420.21; which met or exceeded the minimum statutory requirement.



JAI ALAI PERMITHOLDERS



Florida was the first state in the nation to conduct jai alai performances, with the first fronton being built in 1926. There were 11 jai alai permitholders, of those 10 operated at six frontons throughout Florida. Florida is now the only state where pari-mutuel wagering on live jai alai games is conducted. A total of 761 completed performances, including charity and scholarship performances, were conducted during this past fiscal year, an increase of approximately five percent from the previous fiscal year.

During Fiscal Year 2020/2021, handle wagered on live jai alai performances decreased by approximately 23 percent. Intertrack handle wagered on broadcasts of live Florida jai alai performances increased by approximately six percent. Total handle decreased by approximately four percent for the Florida jai alai industry.

Total jai alai revenue to the state decreased by approximately 0.3 percent during Fiscal Year 2020/2021. The jai alai industry accounted for approximately five percent of Florida's total pari-mutuel revenue and 1.15 percent of total handle from pari-mutuel performances.

Permitholders reported paying a total of \$4,097,079 in players' awards. For more detail on players' awards paid, please refer to pages eight and nine of this annual report.

There was no paid attendance for jai alai permitholders in Fiscal Year 2020/2021. The division reports only paid attendance and does not include free admissions or complimentary passes in its data.



THOROUGHBRED PERMITHOLDERS



Florida continues to be a premier thoroughbred racing state with five permitholders that operated at three tracks located in Central and South Florida. A total of 315 completed performances, including charity and scholarship performances, were conducted during this past fiscal year, a decrease of approximately eight percent from the previous fiscal year.

During Fiscal Year 2020/2021, handle on live thoroughbred performances decreased by 29 percent. Handle from intertrack wagering increased approximately six percent. Simulcast handle wagered on broadcasts of performances from outside the state decreased by approximately 38 percent. Intertrack simulcast handle increased by approximately 25 percent. Overall, total handle increased by approximately two percent for the Florida thoroughbred industry.

Total thoroughbred revenue to the state during Fiscal Year 2020/2021, increased by approximately 11 percent from the prior year. The thoroughbred industry accounted for approximately 76 percent of Florida's total pari-mutuel revenue and 64.71 percent of total handle from pari-mutuel performances.

Permitholders reported paying a total of \$90,697,594 in purses. For more detail on purses paid, please refer to pages eight and nine of this annual report. The Florida Horsemen's Benevolent and Protective Association did not dispute the amount of purses paid reported by the permitholders. The Tampa Bay Horsemen's Benevolent and Protective Association, Inc., did not dispute the amount of purses paid reported by Tampa Bay Downs.

Total paid attendance decreased by approximately 10 percent from the prior year. The division reports only paid attendance and does not include free admissions or complimentary passes in its data.



HARNESS PERMITHOLDERS



Pompano Park is the only permitholder conducting harness horse racing in the State of Florida. A total of 105 completed performances, including charity and scholarship performances, were conducted during this past fiscal year, which is an increase of approximately 17 percent from the previous year.

During Fiscal Year 2020/2021, handle wagered on live harness performances increased by approximately 27 percent. Intertrack handle wagered on broadcasts of live Florida harness performances increased by approximately 63 percent. Simulcast handle wagered on broadcasts of performances from outside the state increased by approximately two percent and intertrack simulcast handle increased by approximately 23 percent. Overall, total handle increased by approximately 20 percent for the Florida harness industry.

Total revenue to the state during Fiscal Year 2020/2021, increased by approximately 25 percent from the prior fiscal year. The harness industry accounted for approximately 11 percent of Florida's total pari-mutuel revenue and 7.10 percent of total handle from pari-mutuel performances.

Pompano Park reported paying \$7,263,441 in purses. For more detail on purses paid, please refer to pages eight and nine of this annual report. The Florida Standardbred Breeders' and Owners' Association was able to confirm the amount of purses paid reported by Pompano Park.

The harness permitholder did not have paid attendance during Fiscal Year 2020/2021. The division reports only paid attendance and does not include free admissions or complimentary passes in its data.



QUARTER HORSE PERMITHOLDERS



There were six quarterhorse permitholders, of those two conducted quarter horse racing at two tracks located in the State of Florida. In Fiscal Year 2020/2021, a total of 40 completed performances were conducted, a decrease of approximately 49 percent from the previous fiscal year.

During Fiscal Year 2020/2021, handle wagered on live quarter horse performances decreased by approximately 87 percent. No intertrack wagering on broadcasts of performances was held; with no change from the prior year. There was no simulcast handle wagered on broadcasts of performances from outside the state, along with no intertrack simulcast handle. Overall, total handle decreased by approximately 87 percent for the Florida quarter horse industry.

Total quarter horse revenue to the state during Fiscal Year 2020/2021, decreased by approximately 47 percent. The quarter horse industry accounted for approximately one percent of Florida's total pari-mutuel revenue and 0.001 percent of total handle from pari-mutuel performances.

Permitholders reported paying a total of \$1,223,600 in purses. For more detail on purses paid, please refer to pages eight and nine of this annual report. The majority of horsemen's association operating at each respective quarterhorse track did not dispute the amount of reported purses paid.

The division reports only paid attendance and does not include free admissions or complimentary passes in its data.



SUMMARY

PARI-MUTUEL INDUSTRY

During Fiscal Year 2020/2021, the total handle wagered for all industries exceeded \$449 million, a decrease of approximately 0.8 percent from the prior fiscal year. Total pari-mutuel completed performances, including charity and scholarship performances, conducted during Fiscal Year 2020/2021, decreased by approximately 40.6 percent from the previous fiscal year.

The state realized revenue from performances of approximately \$5.8 million, a increase of approximately 10.5 percent from the prior fiscal year. Of the \$5.8 million collected, greyhound permitholders accounted for seven percent, thoroughbreds for 76 percent, harness for 11 percent, jai alai for five percent, and quarter horse for one percent.

Total paid attendance decreased approximately 73 percent from the prior year. The division reports only paid attendance and does not include free

CHARITY AND SCHOLARSHIP PERFORMANCES

Each permitholder may operate up to five additional days designated as charity or scholarship days during their regular meet. Pursuant to Section 550.0351, Florida Statutes, proceeds from these additional days are paid to approved charities, major state and private institutions of higher learning, community colleges, the Historical Resources Operating Trust Fund, and the Racing Scholarship Trust Fund (Board of Governors' Operations and Maintenance Trust Fund). A list of proposed recipients is submitted annually by the permitholder to the division. A minimum of \$1,225,350 was paid to charitable organizations during Fiscal Year 2020/2021, bringing the total proceeds disbursed since 1985 to \$88,272,695.

ABANDONED WINNING TICKETS

Abandoned pari-mutuel tickets are winning tickets that remain uncashed for a period of one year. The value of greyhound and jai alai abandoned tickets for live on-track races or games escheat to the state. These funds are deposited into the Department of Education's State School Trust Fund for the support and maintenance of Florida's public schools. Since 1957, the total paid into this fund is \$99,735,775. The amount collected from abandoned winning tickets for the State School Trust Fund for this fiscal year is detailed below.

In harness and quarterhorse racing, abandoned winning tickets are paid to the respective breeders' associations. Abandoned winning tickets from thoroughbred horse racing are retained by the permitholder.

MISCELLANEOUS REVENUE TO THE STATE

In accordance with Section 550.095114(4), Florida Statutes, a jai alai permitholder that conducts fewer than 100 live performances in any calendar year shall pay to the state the same aggregate amount of daily license fees on live jai alai games, admission tax, and tax on live handle as that permitholder paid to the state during the most recent prior calendar year in which jai alai permitholder conducted at least 100 live performances.



CARDROOM COMPARATIVE DATA

During Fiscal Year 2020/2021, there were 26 permitholders that obtained a cardroom license. Of those, 24 operated at pari-mutuel facilities located throughout the state. The number of cardroom tables decreased from 796 in Fiscal Year 2019/2020, to 782 in Fiscal Year 2020/2021. Cardroom gross receipts increased from \$132,392,085 to \$151,179,359 and the gross receipts tax increased from \$13,239,209 to \$15,117,936 this fiscal year. Table fees decreased from \$796,000 to \$782,000 this fiscal year. The overall result was an increase in total state revenue from \$14,035,209 to \$15,899,936 this fiscal year.

Cardroom tax revenue is distributed 50 percent between the Pari-Mutuel Wagering Trust Fund and the General Revenue Fund. In accordance with Section 849.086(13)(h), Florida Statutes, one quarter of the moneys deposited into the Pari-Mutuel Wagering Trust Fund must be distributed to counties and municipalities that approved the cardroom. In October 2021, the division distributed approximately \$1,889,742 to the counties/municipalities from cardroom gross receipts.

SLOT COMPARATIVE DATA

During Fiscal Year 2020/2021, the total amount wagered by patrons was \$7,702,629,923. Total net slot revenue was \$510,749,698. As a result, the total taxes paid to the state was \$178,762,395, a 16 percent increase in total paid slot taxes from the previous state fiscal year. A total of \$18 million was collected in annual slot license fees, including the Compulsive or Addictive Gambling Prevention Program Fee, per Section 551.118(3), Florida Statutes.
