FINAL ORDER

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering (“Petitioner” or “Division”), hereby enters this Final Order against Erick Vazquez (“Respondent”), and states as follows:

1. An Administrative Complaint was filed in this case on September 17, 2018, alleging that Respondent violated provisions of section 550.105, Florida Statutes and rule 61D-11.011, *Florida Administrative Code* (“Administrative Complaint”). A true and correct copy of the Administrative Complaint is attached hereto as Exhibit “1” and incorporated by reference.

2. Service of the Administrative Complaint was attempted via certified mail on Respondent. Proof of attempted service via certified mail is attached hereto as Exhibit “2” and incorporated by reference.

3. Notice of this matter was served upon Respondent on May 31, 2019, June 7, 2019, June 14, 2019 and June 21, 2019, via publication in the *Miami Daily Business Review*, a publication in general circulation within Miami-Dade County, Florida (“Notice of Action”). A

true and correct copy of the Notice of Action is attached hereto as Exhibit “3” and incorporated by reference.

4. The Notice of Action Election informed Respondent that Petitioner filed an Administrative Complaint against him and provided instructions on how to receive a copy of the Administrative Complaint and that contact would be required to dispute the allegations within the Administrative Complaint. See § 120.569(1), Fla. Stat. and Fla. Admin. Code R. 28-106.111.

5. In addition, the Notice of Action informed Respondent that the failure to timely file a response to the Administrative Complaint would be deemed a waiver of right to a hearing or resolution in this matter.

6. To date, Respondent has not submitted an Election of Rights form or otherwise provided a response to the Administrative Complaint filed and served in this action.

Upon consideration of the facts and conclusions of law delineated in the Administrative Complaint, it is ORDERED:

7. The allegations of fact set forth in the Administrative Complaint are approved, adopted and incorporated herein by reference as findings of fact by the Division.

8. The conclusions of law alleged and set forth in the Administrative Complaint are approved, adopted, and incorporated herein by references as the conclusions of law by the Division.

9. There is competent substantial evidence to support the findings of fact and conclusions of law by the Division.



ADMINISTRATIVE COMPLAINT

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering (Petitioner), files this Administrative Complaint against Erick Vazquez (Respondent), and alleges as follows:

1. Petitioner is the state agency charged with regulating pari-mutuel wagering pursuant to Chapters 550 and 551, Florida Statutes.
2. Respondent's address of record is 3332 South West 179<sup>th</sup> Avenue, Miramar, Florida 33029.
3. Fronton Holdings, LLC, d/b/a Casino Miami Jai-Alai, is a facility operated by a permitholder authorized to conduct pari-mutuel wagering and slot games in this state under Chapters 550 and 551, Florida Statutes.
4. On or about June 11, 2017, Respondent was issued a trespass warning and permanent exclusion from Casino Miami Jai-Alai.
5. Section 550.0251, Florida States, provides, in relevant part:  

(6) in addition to the power to exclude certain persons from any pari-mutuel facility in the state, the division may exclude any

person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division. The division may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state...

WHEREFORE, Petitioner respectfully requests the Division Director enter an Order permanently excluding Respondent from all licensed pari-mutuel facilities in the state of Florida.

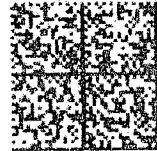
