#### FINAL ORDER

This matter appeared before the Florida Gaming Control Commission at a duly-noticed public meeting on May 2, 2023, for final agency action pursuant to sections 120.569 and 120.57(2), Florida Statutes. After a complete review of the record in this matter, the Commission makes the following findings of fact and conclusions of law:

- 1. An Administrative Complaint was filed in this case on March 9, 2023, alleging that Respondent is subject to exclusion from all licensed pari-mutuel facilities and all facilities of a slot machine licensee in the state of Florida under sections 550.0251(6) and 551.112, Florida Statutes. A copy of the Administrative Complaint is attached hereto as Exhibit "1" and incorporated by reference.
- 2. The Administrative Complaint, Election of Rights form, an Explanation of Rights, and a cover letter were served on Respondent via certified mail on March 16, 2023. Proof of service is attached hereto as Exhibit "2" and incorporated by reference.
- 3. The Election of Rights form, Explanation of Rights, and cover letter informed Respondent that a written response to the Administrative Complaint, including the right to request

- a hearing, was due within 21 days of actual service of the Administrative Complaint. See § 120.569(1), Fla. Stat., and Fla. Admin. Code. R. 28-106.111.
- 4. Petitioner informed Respondent that the failure to file a timely response to the Administrative Complaint would be deemed a waiver of the right to a hearing.
- 5. Respondent has not filed a timely response to the Administrative Complaint.
  Respondent has not submitted any evidence or made any allegations that would support the application of the doctrine of equitable tolling.

Having considered the Administrative Complaint, the service of the Administrative Complaint with Election of Rights form, Explanation of Rights, and cover letter on Respondent along with Respondent's failure to respond, and being otherwise fully advised in the premises, it is hereby

#### ORDERED and ADJUDGED:

- 6. The allegations of fact and the conclusions of law in the Administrative Complaint are adopted in their entirety herein.
- 7. Respondent is hereby **PERMANENTLY EXCLUDED** from all pari-mutuel facilities and all facilities of a slot machine licensee within the State of Florida.

This Final Order shall take effect upon being filed with the Clerk of the Commission.



#### ADMINISTRATIVE COMPLAINT

The Florida Gaming Control Commission, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Yoan Perez Jimenez ("Respondent"), and alleges:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering, slot machines, and cardroom operations pursuant to chapters 550, 551, and 849, Florida Statutes.
- 2. At all times material hereto, Respondent's address was reported as 228 West 15th Street Hialeah, Florida 33010.
- 3. At all times material hereto, the Casino at Dania Beach was a facility operated by a permitholder authorized to conduct pari-mutuel wagering, slot machines, and cardroom operations in the state of Florida.
- 4. On or about January 15, 2023, Respondent was working as a designated player at the Casino at Dania Beach.
- 5. On or about January 19, 2023, Respondent was permanently excluded from the Casino at Dania Beach.



- 6. Respondent was permanently excluded for the reasons alleged in Exhibit 1.
- 7. Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any parimutuel facility in this state, the commission may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the commission. The commission may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

#### (Emphasis supplied).

8. Section 551.112, Florida Statutes, provides:

In addition to the power to exclude certain persons from any facility of a slot machine licensee in this state, the commission may exclude any person from any facility of a slot machine licensee in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the commission. The commission may exclude from any facility of a slot machine licensee any person who has been ejected from a facility of a slot machine licensee in this state or who has been excluded from any facility of a slot machine licensee or gaming facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over the gaming in such other state. This section does not abrogate the common law right of a slot machine licensee to exclude a patron absolutely in this state.

#### (Emphasis supplied).

9. Based on the foregoing, Respondent is subject to exclusion from all licensed parimutuel wagering facilities and any facility of a slot machine licensee in the state of Florida under sections 550.0251(6) and 551.112, Florida Statutes based on his permanent exclusion from the Casino at Dania Beach on or about January 19, 2023.

WHEREFORE, Petitioner respectfully requests the Florida Gaming Control Commission enter an Order excluding Respondent from all licensed pari-mutuel wagering facilities and any facility of a slot machine licensee in the state of Florida, along with any other remedy provided by chapters 550 and 551, Florida Statutes, and/or the rules promulgated thereunder.

Mediation under section 120.573, Florida Statutes, is not available to resolve this Administrative Complaint.

Synopsis: YOAN PEREZ JIMENEZ as a Designated Player for Card Tech engaged in a theft partnership with Hung Pham. PHAM positioned himself next to PEREZ JIMENEZ while Pompano Park 02-17-23 was acting as a DP at Casino Dania Beach. During card games, PEREZ JIMENEZ simply handed off chips to Pham totaling approximately \$1250 in value. This partnership theft has resulted in both Pham and PEREZ JIMENEZ being Lifetime Excluded from the facility.

Hung Pham engaged in a theft partnership with Card Tech Designated Player (DP) Yoan PEREZ JIMENEZ. On multiple occasions during January 15, 2023, Pham positioned himself next to PEREZ JIMENEZ while PEREZ JIMENEZ was acting as a DP at Casino Dania Beach. During card games, PEREZ JIMENEZ simply handed off chips to Pham totaling approximately \$1250 in value. The chips passed off to Pham were capital provided to PEREZ JIMENEZ from his employer, Card Tech. Video surveillance recordings confirmed the theft(s). This partnership theft has resulted in both Pham and PEREZ JIMENEZ being Lifetime Excluded from the facility (EXHIBITS #1 & #2).

Yoan PEREZ JIMENEZ was a "Designated Player" for Card Tech (CT) which is one of several organizations which finances players to operate on the organization's behalf. Designated Players are agents of the company they work for. This is a common relationship / activity in the state of Florida due to the prohibition of house (facility) backed table games. While acting as a Designated Player, PEREZ JIMENEZ would receive losing wagers and pay winning wagers on behalf of Card Tech using funds provided by Card Tech.

The facility Surveillance Report details the multiple theft events which occurred at four (4) different tables over the course of approximately six hours and thirty minutes. For simplicity of explanation, **PEREZ JIMENEZ'S** primary technique of transfer was to shuffle and play with chips in his right hand. Pham was positioned next to him. **PEREZ JIMENEZ** would periodically let go of the chips and Pham would take possession of them from his left. This Investigator reviewed the surveillance recordings (**EXHIBIT #3**) and confirmed the theft activity.

Conclusion: As a result of their actions both Pham and PEREZ JIMENEZ have been issued lifetime exclusions form the Casino@Dania Beach and are subject to exclusion from all pari-mutuel facilities in the state of Florida.

Status: Closed by Investigations and forwarded to Legal for review.







#### Narrative

On January 18th, 2023, at 13:44 hrs, Surveillance was notified of an incident at Poker Table #19 on gaming day, January 15th, of an unknown A/M, later identified as Hung Q Pham at seat # 5 and was given cheques from Designated Player( Yoan Perez Jimenez) at seat # 6.

#### Summary:

Yoan Perez Jimenez, throughout the time at each table, constantly played with the cheques in his hand after he would place the cheques between himself and Hung Q Pham. Pham had bought in at the Poker Cage for \$200 in cash for cheques. Pham left table # 17 \$1,200 to table #19, where Pham left with \$1,605 in cheques. Pham bought in for \$100 at Poker Cage before heading to The Grill dining area to eat. After Pham ate at The Grill, he arrived at the Poker Room, began wagering at table # 22, and left Poker Table # 22 with \$1,250. Jimenez and Pham conducted the same scam throughout the night until Pham left at 23:00.

The video revealed the following:

- At 11:49:04 hrs, Hung Q Pham entered the Fronton Entrance.
- At 11:59:36 hrs, Pham bought in at the Poker Cage for \$200 cash for cheques.
- At 11:59:56 hrs, Pham was observed leaving Poker Cage and entering the Poker room.
- At 12:00:12 hrs, Pham was observed approaching and speaking to the Designated Player (Yoan Perez Jimenez) at Poker Table # 17 in seat # 6.

#### Table 17

- At 12:01:50 hrs, Poker Dealer Felix Alberto De Jesus was observed arriving at Deal at Poker Table # 17.
- At 12:01:55 hrs, Pham at Poker Table # 17, seat 6, was observed continually speaking to the Designated Player(
   Yoan Perez Jimenez) while seated at the table.
- At 12:03:03 hrs, the Designated Player was observed motioning with his right hand for Pham to place his wagering bets and where to place them.
- At 12:03:10 hrs, Pham was observed placing bets on Poker Table # 17, seat 6.
- At 12:03:19 hrs, Poker hands begin.

Note: the Designated Player( Yoan Perez Jimenez) was observed trying to slide over an undisclosed amount of green cheques to Hung Q Pham at Poker Table # 17, seat 6.

- At 12:11:38 hrs, the Designated Player was observed tossing 4 green cheque totaling \$100.00 to Pham after the poker hand was completed.
- At 12:13:31 hrs, Pham, on Poker Table # 17, seat 6, was observed handing the Designated Player 20 red cheques totaling \$100.00.
- At 12:13:45 hrs, the Designated Player was observed handing Pham an undisclosed amount of green cheques on Poker Table # 17, seat 6.
  - o undisclosed amount appears clearly over \$100.00 in green cheques.
- At 12:18:47 hrs, Pham was observed handing the Designated Player 3 green cheques totaling \$75.00 at Poker Table \$ 17 seat 6.
- At 12:19:03 hrs, Designated Player was observed handing Pham 20 red cheques totaling \$100.00 and 2 green cheques totaling \$50.00 for a combined total of \$150.00 on Poker Table # 17, seat 6.
  - o the Designated played gave Pham an extra \$75.00 in cheques.
- At 12:29:44 hrs, Poker Dealer Ricardo Hernandez was observed arriving at Deal at Poker Table # 17.
- At 12:30:04 hrs, Pham was observed handing the Designated Player 16 red cheques totaling \$80.00 at Poker Table \$ 17 seat 6.
- At 12:30:28 hrs, Designated Player was observed handing Pham 6 green cheques totaling

EXHIBIT # \$150.00 on Poker Table PAGE #

- # 17, seat 6.
  - o the Designated Player gave Pham an extra \$ 70.00 in cheques.
- At 12:35:59 hrs, Pham was observed handing the Designated Player 4 green cheques totaling \$100.00 at Poker Table \$ 17 seat 6.
- At 12:36:26 hrs, Designated Player was observed handing Pham 15 red cheques totaling \$75.00 and 3 green cheques totaling \$75.00 for a combined total of \$150.00 on Poker Table # 17, seat 6.
  - o the Designated Player gave Pham an extra \$50.00 in cheques.
- At 12:50:17 hrs, Pham was observed handing the Designated Player 4 green cheques totaling \$100.00 at Poker Table \$ 17 seat 6.
- At 12:50:32 hrs, Designated Player was observed handing Pham 20 red cheques totaling \$100.00 and 4 green cheques totaling \$100.00 for a combined total of \$200.00 on Poker Table # 17, seat 6.
  - o the Designated Player gave Pham an extra \$100.00 in cheques.
- At 12:54:07 hrs, Pham was observed handing the Designated Player 3 green cheques totaling \$75.00 at Poker Table \$ 17 seat 6.
- At 12:54:20 hrs, Designated Player was observed handing Pham 15 red cheques totaling \$75.00 and 4 green cheques totaling \$100.00 for a combined total of \$175.00 on Poker Table # 17, seat 6.
  - o the Designated Player gave Pham an extra \$100.00.
- At 13:00:00 hrs, Poker Dealer Barbara Hausman was observed arriving at Deal at Poker Table # 17.
- At 13:05:50 hrs, Designated Player was observed purposely spilling a complete stack of greens (20 green cheques totaling \$500.00) and pushing an undisclosed amount to Pham on Poker Table # 17, seat 6.
- At 13:05:56 hrs, Pham was observed retrieving an undisclosed amount of green cheques from Designated Player on Poker Table # 17, seat 6. The cheques were passed between the designated player and Pham.

Note: the undisclosed amount of cheques appear to be between \$200.00 to \$300.00. Between

- At 13:16:20 hrs, Designated Player was observed counting Pham green cheques on Poker Table # 17, seat 6, for \$550.00.
- At 13:30:29 hrs, Poker Dealer Anthony Larocca was observed arriving at Deal at Poker Table # 17.
- At 13:34:14 hrs, Anthony Larocca was observed tossing three red cheques totaling \$15.00 to the Designated player on Poker Table # 17.
- At 13:34:15, Pham was observed sliding the 3 red cheques over to the Designated player on Poker Table # 17, seat 6.
- At 13:34:20 hrs, Designated Player was observed retrieving the 3 red cheques and then placing them on top of Pham bet on Poker Table # 17, seat 6.
- At 13:34:23 hrs, Pham was observed retrieving the 3 red cheques from the top of the bet and combining them with his cheques on Poker Table # 17, seat 6.
- At 13:37:17 hrs, Designated Player was observed placing 3 green cheques totaling \$75.00 directly in front of Pham on Poker Table # 17, seat 6.
- At 13:37:30 hrs, Pham was observed retrieving the 3 green cheques and combining them with his cheques at Poker Table # 17, seat 6.
- At 13:40:03 hrs, Designated Player was observed taking Pair Plus and Tripp's bets off-hand and tossing the 2 red cheques toward Pham on Poker Table # 17, seat 6.
- At 13:46:46 hrs, Pham was observed leaving Poker Table # 17, seat 6 Simulcast, outside the balcony.
- At 13:47:52 hrs, Pham was observed on Simulcast outside the balcony.
- At 13:48:35 hrs, Designated Player was observed adding an undisclosed amount of green cheques to Pham cheques while the patron was away at Poker Table # 17, seat 6.
- At 13:49:31 hrs, Pham was observed leaving Simulcast outside balcony and walking towards Poker room Poker Table # 17.
- At 13:50:41 hrs, Pham was observed on Poker Table # 17, seat 6.
- At 13:58:56 hrs, Pham was observed handing the Designated Player 4 green cheques totaling \$100.00 at Poker Table \$ 17, seat 6.
- At 13:59:25 hrs, Designated Player was observed handing Pham 20 red cheques totaling \$100.00 and 4 green cheques totaling \$100.00 for a combined total of \$200.00 on Poker Table # 17, seat 6.
   the Designated Player gave Pham an extra \$100.00.
- At 13:59:46 hrs, Poker Dealer Nathan Mann was observed arriving at Deal at Poker Table # 17.
