#### FINAL ORDER

This matter appeared before the Florida Gaming Control Commission at a duly-noticed public meeting October 5, 2023, for final agency action pursuant to sections 120.569 and 120.57(2), Florida Statutes. After a complete review of the records in this matter, the Commission makes the following findings of fact and conclusions of law:

1. An Administrative Complaint was filed in this case on June 27, 2023, alleging that Respondent is in violation of rule 75-11.005(4), Florida Administrative Code, and alleging that Respondent is subject to exclusion from all licensed pari-mutuel facilities in the state of Florida under sections 550.0251(6), Florida Statutes. A copy of the Administrative Complaint is attached hereto as Exhibit "1" and incorporated by reference.

2. The Administrative Complaint, Election of Rights form, an Explanation of Rights, and a cover letter were served on Respondent via mail service on June 30, 2023. Proof of service is attached hereto as Exhibit "2" and incorporated by reference.

3. The Election of Rights form, Explanation of Rights, and cover letter informed Respondent that a written response to the Complaint, including the right to request a hearing, was due within 21 days of actual service of the Complaints. See § 120.569(1), Fla. Stat., and Fla. Admin. Code R. 28-106.111.

4. Petitioner informed Respondent that the failure to file a timely response to the Complaint would be deemed a waiver of the right to a hearing.

5. Respondent has not filed a timely response to the Complaint. Respondent has not submitted any evidence or made any allegations that would support the application of the doctrine of equitable tolling.

Having considered the Complaint, the service of the Complaint with Election of Rights form, Explanation of Rights, and cover letter on Respondent along with Respondent's failure to respond, and being otherwise fully advised in the premises, it is hereby:

ORDERED and ADJUDGED:

6. The allegations of fact and the conclusions of law in the Administrative Complaint are adopted in their entirety herein.

7. Respondent is hereby **PERMANENTLY EXCLUDED** from all pari-mutuel facilities within the state of Florida.

This Final Order shall take effect upon being filed with the Clerk of the Commission.

#### ADMINISTRATIVE COMPLAINT

The Florida Gaming Control Commission, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Michelle Celeste Valdivia Palacios ("Respondent"), and alleges:

1. Petitioner is the state agency charged with regulating pari-mutuel wagering and cardroom operations pursuant to chapters 550 and 849, Florida Statutes.

2. At all times material hereto, St. Petersburg Kennel Club, Inc. was a facility operated by a permitholder authorized to conduct pari-mutuel wagering and cardroom operations in the State of Florida.

3. At all times material hereto, Respondent held a Pari-Mutuel Wagering General Individual Occupational License, number 11941317-1022, issued by Petitioner.

4. On or about February 22, 2023, Respondent was employed as a Cardroom Cocktail Waitress at St. Petersburg Kennel Club, Inc.

5. On or about February 22, 2023, Respondent was seen transferring patron's meals and meals for herself to a private prime comp check to be paid by the facility, which is against company policy.

6. Following the discovery of the incident and questioning by investigations, Respondent voluntarily resigned from St. Petersburg Kennel Club, Inc.

#### COUNT I

7. Petitioner realleges and incorporates the allegations contained within paragraphs one through six as though fully set forth herein.

8. Rule 61D-11.005(4), Florida Administrative Code, provides, in pertinent part, that "[n]o person shall, either directly or indirectly (a) [e]mploy or attempt to employ any device, scheme, or artifice to defraud any participant in a game or the cardroom operator."

9. Based on the foregoing, Respondent violated rule 61D-11.005(4), Florida Administrative Code, by employing a device, scheme, or artifice to defraud the cardroom operator.

#### <u>COUNT II</u>

10. Petitioner realleges and incorporates the allegations contained within paragraphs one through six as though fully set forth herein.

11. Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any parimutuel facility in this state, <u>the commission may exclude any person</u> from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this <u>chapter or the rules of the commission</u>. The commission may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state. (Emphasis supplied).

12. Based on the foregoing, Respondent is subject to exclusion from all licensed parimutuel wagering facilities in the state of Florida under section 550.0251(6), Florida Statutes, based on her violation of rule 61D-11.005(4), Florida Administrative Code. WHEREFORE, Petitioner respectfully requests the Florida Gaming Control Commission enter an Order excluding Respondent from all licensed pari-mutuel wagering facilities in the state of Florida, and any other remedy provided by chapters 550 and 849, Florida Statutes, and/or the rules promulgated thereunder.

Mediation under section 120.573, Florida Statutes, is not available to resolve this Administrative Complaint.
