#### FINAL ORDER

This matter appeared before the Florida Gaming Control Commission at a duly-noticed public meeting on March 6, 2024, for final agency action pursuant to sections 120.569 and 120.57(2), Florida Statutes. After a complete review of the record in this matter, the Commission makes the following findings of fact and conclusions of law:

1. An Administrative Complaint was filed in this case on December 18, 2023, alleging that (i) Respondent is subject to exclusion from all licensed pari-mutuel facilities in the state of Florida pursuant to section 550.0251(6), and (ii) Respondent is subject to the suspension or revocation of his occupational license, pursuant to section 849.086(14)(a), Florida Statutes. A copy of the Administrative Complaint is attached hereto, marked as Exhibit A, and incorporated herein.

2. Respondent was served with the Administrative Complaint, Election of Rights form, an explanation of rights and cover letter via Certified Mail on December 26, 2023. Proof of service is attached hereto, marked as Exhibit B, and incorporated herein.

3. The Election of Rights form, explanation of rights, and cover letter notified Respondent that a written response to the Administrative Complaint, including the right to request

a hearing, was due within 21 days of actual service of the Administrative Complaint. See § 120.569(1), Fla. Stat., and Fla. Admin. Code. R. 28-106.111.

4. Petitioner notified Respondent that the failure to file a timely response to the Administrative Complaint would be deemed a waiver of the right to a hearing.

5. Respondent failed to file a timely response to the Administrative Complaint, and has not submitted any evidence or made any allegations that would support the application of the doctrine of equitable tolling.

Having considered the Administrative Complaint, the service of the Administrative Complaint with Election of Rights form, explanation of rights, and cover letter on Respondent along with Respondent's failure to respond, and being otherwise fully advised in the premises, it is hereby

ORDERED and ADJUDGED:

1. The allegations of fact and the conclusions of law in the Administrative Complaint are adopted in their entirety herein.

2. Respondent is hereby **PERMANENTLY EXCLUDED** from all pari-mutuel facilities within the state of Florida.

3. Respondent's Cardroom Employee Occupational License, number 8268733, is hereby **REVOKED**.

This Final Order shall take effect upon being filed with the Clerk of the Commission.

### ADMINISTRATIVE COMPLAINT

1. The Florida Gaming Control Commission, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Frank C. Hurlbert ("Respondent"), and alleges:

2. Petitioner is the state agency charged with regulating pari-mutuel wagering, slot machines, and cardroom operations pursuant to chapters 550, 551, and 849, Florida Statutes.

3. At all times material hereto, Respondent held a Cardroom Employee Occupational License, number 8268733, issued pursuant to section 849.086(6), Florida Statutes.

4. At all times material hereto, Melbourne Greyhound Park, LLC was a facility operated by a permitholder authorized to conduct pari-mutuel wagering and cardroom operations in the state of Florida pursuant to chapters 550 and 849, Florida Statutes.

5. Respondent was employed as a poker dealer at Melbourne Greyhound Park, LLC.

6. On or about September 22, 2023, Respondent was observed via surveillance footage stealing chips from the players during live poker games.



7. On September 29, 2023, Respondent was terminated from his employment as a poker dealer at Melbourne Greyhound Park, LLC.

#### <u>COUNT I</u>

8. Petitioner realleges and incorporates the allegations contained within paragraphs one through seven as though fully set forth herein.

9. Rule 75-11.005(4), Florida Administrative Code, provides, in pertinent part, that

"[n]o person shall, either directly or indirectly (a) [e]mploy or attempt to employ any device,

scheme, or artifice to defraud any participant in a game or the cardroom operator."

10. Section 849.086(14)(a), Florida Statutes, provides that:

The commission may deny a license or the renewal thereof, or may suspend or revoke any license, when the applicant has: violated or failed to comply with the provisions of this section or any rules adopted pursuant thereto; knowingly caused, aided, abetted, or conspired with another to cause any person to violate this section or any rules adopted pursuant thereto; or obtained a license or permit by fraud, misrepresentation, or concealment; or if the holder of such license or permit is no longer eligible under this section.

11. Based on the foregoing, Respondent violated rule 75-11.005(4), Florida

Administrative Code, by employing a device, scheme, or artifice to defraud the participants of

games and is therefore subject to suspension or revocation of her occupational license.

#### <u>COUNT II</u>

12. Petitioner realleges and incorporates the allegations contained within paragraphs

one through seven as though fully set forth herein.

13. Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any parimutuel facility in this state, <u>the commission may exclude any person</u> from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the commission. The commission may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

(Emphasis supplied).

14. Based on the foregoing, Respondent is subject to exclusion from all licensed pari-

mutuel wagering facilities in the state of Florida based on his termination for theft from Melbourne

Greyhound Park, LLC on September 29, 2023.

WHEREFORE, Petitioner respectfully requests the Florida Gaming Control Commission enter an Order revoking or suspending Respondent's Occupational License and excluding Respondent from all licensed pari-mutuel wagering facilities in the state of Florida, along with any other remedy provided by chapters 550 and 849 Florida Statutes, and/or the rules promulgated thereunder.

Pursuant to rule 28-106.111, Florida Administrative Code, you must request a hearing within 21 days from receipt of this Notice, or you will waive your right to request a hearing.

Mediation under section 120.573, Florida Statutes, is not available to resolve this Administrative Complaint.

#### CONTINUATION

On September 28, 2023, I received a phone call from Melbourne Greyhound Park LLC (MGP), Club 52 Poker Room Director, Jeffrey Marr (License #8220517, - Expires 06-30-2024). Marr wanted advice on how to proceed with a Poker Dealer whom he discovered stealing chips from the pot to his well (tip box) on several occasions. Marr identified the Dealer as Frank HURLBERT (Lic. # 8268733 – Exp. June 30, 2024) Marr stated he discovered the thefts by observing surveillance video coverage while conducting dealer evaluations. On September 29, 2023, Marr terminated **HURLBERT'S** employment and provided related information to this Investigator **(Exhibit #3)**.

On October 4, 2023, I responded to Melbourne Greyhound Park LLC (Club 52). I met with Director Jeffrey Marr to retrieve a USB flash drive containing the surveillance video footage, and all pertinent documentation of this incident. Marr stated on the evening of September 22, 2023, at approximately 8:00 P.M., Frank **HURLBERT** who was the Dealer at table #9, was observed taking \$5.00 dollars in chips out of the pot and inserting them into his well. Marr further stated that from that time until 8:25 P.M., he observed **HULBERT** on video surveillance footage doing the same thing on 10 different occasions. In addition, during that same time frame **HULBERT** was observed taking \$4.00 dollars out of the rake and placing it into his well along with a \$1.00 dollar tip he received from a customer. Marr also stated that when the next dealer came to table #9 at 8:25 P.M., to relieve **HURLBERT**, **HURLBERT** was known to have \$1,000.00 dollars in green chips in his well. When returning his well to the cage after dealing, it was discovered that \$50.00 dollars in green chips were missing, and at the same time, **HURLBERT** was observed placing the chips into his tip box.

Marr added that there were other times and dates **HURLBERT** has been observed taking \$5.00 dollar chips out of the pot and placing the chips into his well. **HURLBERT** had a system for knowing how much money in chips he was placing into his well by putting clear spacers/lammers in a different spot in his well to count with. All of this can be seen on the video footage that has been provided **(Exhibit #7).** 

Independent video review by this Investigator corroborated what was documented<sup>1</sup>. The following was noted:

Table #9 camera20:00:55- \$10.00 dollars from pot to well.20:01:30- \$5.00 dollars from pot to well.20:03:29- \$5.00 dollars from pot to well.20:05:43- \$5.00 dollars from pot to well.20:06:54- \$5.00 dollars from pot to well.20:08:24- \$5.00 dollars from pot to well.20:11:22- \$5.00 dollars from pot to well.20:14:37- \$5.00 dollars from pot to well.20:14:37- \$5.00 dollars from pot to well.20:18:47- \$5.00 dollars from pot to well.20:18:47- \$5.00 dollars from pot to well.20:19:01- \$4.00 dollars from house rake and \$1.00 dollar tip from player.20:24:50- left table with \$1,000.00 dollars in green still in well.

<u>Cage camera</u> - 20:31:30- returned well to cage with \$950.00 dollars in green in the well and observed putting chips in tip box.

#### CONTINUATION

Marr went on to say that that on September 29, 2023, he called **HURLBERT** in for an Employee Counseling, at which time **HURLBERT** refused to answer any questions related to the September 22, 2023, theft. **HURLBERT** was immediately terminated. Marr then called the Melbourne Police Department, 650 N. Apollo Blvd. Melbourne, Florida 32935 (321) 608-6731 to initiate a report and investigation into the theft. Officer Rymer badge responded and provided the Marr with report #MP23-66879 (Exhibits 4 & 5).

The USB flash drive containing the surveillance video was mailed to the PMW Office of Investigations located at 1400 West Commercial Blvd., Suite 165, Ft. Lauderdale, FL. 33309 also known as the North Broward Regional Service Center as evidence and placed into the property evidence room. A property receipt was completed **(Exhibit #7).** 

**Conclusion**: Through his actions, **HURLBERT** a licensed Poker Dealer, has been terminated from the Melbourne Greyhound Park LLC, a licensed Pari-Mutuel Wagering facility in Melbourne, Florida for theft. A police report has been initiated by the management of MGP (Club 52). The report and evidence substantiate consideration for a revocation of **HURLBERT'S** cardroom license.

Status: Case closed by Investigations and forwarded to Legal for review and appropriate action.

This correspondence is provided on behalf of Melbourne Greyhound Park, LLC ("Melbourne") for the purpose of submitting a complaint against Frank C. Hurlbert, the holder of cardroom employee occupational license number 8268733.

Mr. Hurlbert was hired as a dealer at Melbourne's cardroom on August 13, 2018. After reviewing security camera footage from September 22, 2023, it became apparent that Mr. Hurlbert was stealing chips from pot and the rake. Upon discovering this information, Melbourne notified the Melbourne Police Department, which has opened an investigation. Mr. Hurlbert was terminated by Melbourne on September 29, 2023.

Melbourne is requesting that the Commission promptly initiate an investigation into Mr. Hulbert's illegal actions at Melbourne and seek the revocation of his occupational license. To this end, please find attached the following evidence:
