HEARING OFFICER'S RECOMMENDED ORDER

THIS MATTER came before Renee Harkins, designated Hearing Officer for the Florida Gaming Control Commission ("Commission"), on January 9, 2025, in Tallahassee, Florida, in accordance with the provisions of sections 120.569 and 120.57(2), Florida Statutes, for consideration of the Commission's Administrative Complaint filed against Elizabeth Rodriguez ("Respondent"), in FGCC Case Number 2024-038843 ("Administrative Complaint"). Emily Alvarado, Chief Attorney, represented the Commission, and the hearing was held telephonically.

PROCEDURAL HISTORY

1. On or about July 25, 2024, the Commission filed an Administrative Complaint against Respondent, alleging that Respondent was a patron of and was ejected and excluded from Fronton Holdings, LLC d/b/a Card House-Port Saint Lucie ("CPSL"), a facility operated by a permitholder authorized to conduct pari-mutuel wagering and cardroom operations in the State of Florida. The Administrative Complaint sought to exclude Respondent from all licensed parimutuel wagering facilities in the State of Florida due to Respondent's ejection and exclusion from CPSL.

- 2. On or about August 27, 2024, the Commission received an amended Election of Rights form from Respondent requesting a telephonic hearing in accordance with the provisions of sections 120.569 and 120.57(2), Florida Statutes.
 - 3. An informal hearing was scheduled for January 9, 2025.

The January 9, 2025, Informal Hearing

- 4. At the informal hearing held on January 9, 2025, the Commission presented the issues raised in its Administrative Complaint. The Hearing Officer granted the Commission's motion to accept the Findings of Fact in the Administrative Complaint as the undisputed facts in the case and admitted the investigative packet into the record.
- 5. The investigative packet that was admitted into the record contained an Investigative Report detailing the activity that led to the permanent ejection and exclusion of Respondent from CPSL.
- 6. At the informal hearing, Respondent testified that she does not gamble. She accompanied her boyfriend, who was playing poker, to CPSL. Respondent began talking to players at tables while games were in progress. She believed she was only receiving a warning at the time and did not realize she was being excluded or issued a trespass warning.

FINDINGS OF FACT

- 7. Petitioner is the state agency charged with regulating pari-mutuel wagering, cardroom, and slot machine operations pursuant to chapters 550 and 849, Florida Statutes.
- 8. At all times material hereto, Fronton Holdings, LLC d/b/a Card House Port Saint Lucie ("CPSL"), was a facility operated by a permitholder authorized to conduct pari-mutuel wagering and cardroom operations in the State of Florida.
 - 9. On or about June 30, 2024, the Respondent was present at CPSL.

- 10. On or about June 30, 2024, Respondent violated house rules of CPSL by disrupting gameplay.
 - 11. On or about June 30, 2024, Respondent was permanently excluded from CPSL.

CONCLUSIONS OF LAW

- 12. The Hearing Officer has jurisdiction over this matter and the parties pursuant to section 120.57(2), Florida Statutes.
- 13. The Commission has jurisdiction over this matter pursuant to chapters 120, 550, and 849, Florida Statutes.
- 14. At all times material hereto, CPSL was a facility operated by a permitholder authorized to conduct pari-mutuel wagering and cardroom operations in the State of Florida.

Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any pari-mutuel facility in this state, the commission may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the commission. The commission may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

(Emphasis supplied.)

- 15. Pursuant to the statutes, Respondent's ejection and exclusion from one facility is enough to trigger an exclusion of the person from all pari-mutuel facilities in the State of Florida.
- 16. Respondent is subject to permanent exclusion from all licensed pari-mutuel wagering facilities in the State of Florida based on Respondent's ejection and permanent exclusion from CPSL.

17. Respondent's testimony neither mitigates that Respondent was ejected and excluded from CPSL nor precludes the Commission from permanently excluding Respondent from all licensed pari-mutuel facilities in the State of Florida.

There is competent substantial evidence to support the conclusions of law.

RECOMMENDED ORDER

Based upon the Findings of Fact and Conclusions of Law, it is hereby recommended that the Florida Gaming Control Commission issue an Order permanently excluding Respondent from all pari-mutuel wagering facilities in the State of Florida.
