FINAL ORDER

This matter appeared before the Florida Gaming Control Commission at a duly-noticed public meeting on November 7, 2025, for final agency action pursuant to sections 120.569 and 120.57(2), Florida Statutes. After a complete review of the records in this matter, the Commission makes the following findings of fact and conclusions of law:

- 1. An Administrative Complaint was filed in this case on August 19, 2025, alleging that Respondent is subject to exclusion from all licensed pari-mutuel facilities and all facilities of a slot machine licensee in the state of Florida pursuant to sections 550.0251(6) and 551.112, Florida Statutes and subject to revocation of his slot machine/cardroom/pari-mutuel combination occupational license pursuant to rule 75-11.005(4), Florida Administrative Code. A copy of the Administrative Complaint is attached hereto as Exhibit "1" and incorporated by reference.
- 2. On or about September 30, 2025, Respondent returned the Election of Rights form and selected "Option 2" which states that Respondent does dispute the allegations of material fact in the Administrative Complaint and requests a formal administrative hearing pursuant to section 120.57(1), Florida Statutes. A copy of the Election of Rights is attached hereto as Exhibit "2" and incorporated by reference.

- 3. On September 30, 2025, the Clerk of the Commission issued an Order of Dismissal with Prejudice and gave Respondent 15 days from the date of the Order of Dismissal to cure the defect. A copy of the Order of Dismissal is attached hereto as Exhibit "3" and incorporated by reference.
- Respondent failed to respond within 15 days from the date of the Order of Dismissal.
- Section 120.569, Florida Statutes, requires the Commission to dismiss the request for formal hearing if the request does not meeting the requirements of Rule 28-106.2015, Fla. Admin. Code.

Having considered the Administrative Complaint and Respondent's failure to respond to the Order of Dismissal without Prejudice to properly request a hearing, and being otherwise fully advised in the premises, it is hereby

ORDERED and ADJUDGED:

- 1. Respondent's request for a hearing is **DISMISSED** with prejudice.
- The allegations of fact and the conclusions of law in the Administrative Complaint are adopted in their entirety herein.
- Respondent slot machine/cardroom/pari-mutuel combination occupational license, number 13599290, is hereby REVOKED.
- Respondent is hereby PERMANENTLY EXCLUDED from all pari-mutuel facilities and all facilities of a slot machine licensee within the state of Florida.

This Final Order shall take effect upon being filed with the Clerk of the Commission.

ADMINISTRATIVE COMPLAINT

The Florida Gaming Control Commission, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Michael Sposato ("Respondent"), and alleges:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering, slot machines, and cardroom operations pursuant to chapters 550, 551, and 849, Florida Statutes.
- At all times material hereto, Respondent held a Slot Machine/Cardroom/Pari-Mutuel Combination Occupational License, number 13599290, issued pursuant to section 551.107(2)(b), Florida Statutes.
- 3. At all times material hereto, PPI, Inc., d/b/a Harrah's Pompano Beach was a facility operated by a permitholder authorized to conduct pari-mutuel wagering, cardroom operations, and slot machine operations in the state of Florida.
- From about June 6, 2025, to June 13, 2025, Respondent worked as a Dealer at Harrah's Pompano Beach.

- From about June 6, 2025, to June 12, 2025, Respondent was observed by Harrah's
 Pompano Beach surveillance stealing \$900 in chips while working at a poker table.
- 6. On or about June 13, 2025, Respondent was observed by Harrah's Pompano Beach surveillance stealing two \$100 black chips while working at a poker table.
- On or about June 13, 2025, Respondent was ejected and permanently excluded from Harrah's Pompano Beach.
- On or about June 13, 2025, Respondent's employment with Harrah's Pompano
 Beach was terminated.

COUNTI

- Petitioner realleges and adopts paragraphs numbered one through eight as if set forth fully herein.
 - 10. Rule 75-11.005(4), Florida Administrative Code, states:

No person shall, either directly or indirectly:

- (a) Employ or attempt to employ any device, scheme, or artifice to defraud any participant in a game or the cardroom operator.
- (b) Engage in any act, practice, or course of operation that would constitute a fraud or deceit upon any participant in a game or the cardroom operator.
- (c) Engage in any act, practice, or course of operation with the intent of cheating any participant or the cardroom operator.
- 11. Pursuant to section 849.086(14)(a), Florida Statutes, "[t]he commission may deny a license or the renewal thereof, or may suspend or revoke any license, when the applicant has: (a) violated or failed to comply with the provisions of this section or any rules adopted pursuant thereto."

12. Based on the foregoing, Respondent violated rule 75-11.005, Florida Administrative Code, by engaging in an act that would constitute fraud or deceit upon the cardroom operator and is therefore subject to suspension or revocation of his occuptional license.

COUNT II

- Petitioner realleges and adopts paragraphs numbered one through eight as if set forth fully herein.
 - 14. Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any parimutuel facility in this state, the commission may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the commission. The commission may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

(Emphasis added).

15. Section 551.112, Florida Statutes, provides:

In addition to the power to exclude certain persons from any facility of a slot machine licensee in this state, the commission may exclude any person from any facility of a slot machine licensee in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the commission. The commission may exclude from any facility of a slot machine licensee any person who has been ejected from a facility of a slot machine licensee in this state or who has been excluded from any facility of a slot machine licensee or gaming facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over the gaming in such other state. This section does not abrogate the common law right of a slot machine licensee to exclude a patron absolutely in this state.

(Emphasis added).

16. Based on the foregoing, Respondent is subject to exclusion from all licensed pari-

mutuel wagering facilities and any facility of a slot machine licensee in the state of Florida based

on his ejection from Harrah's Pompano Beach on June 13, 2025, pursuant to sections 550.0251(6)

and 551.112, Florida Statutes.

WHEREFORE, Petitioner respectfully requests the Florida Gaming Control Commission

enter an Order revoking Respondent's Slot Machine/Cardroom/Pari-Mutuel Combination

Occupational License, number 1599290, and excluding Respondent from all licensed pari-mutuel

wagering facilities and any facility of a slot machine licensee in the state of Florida, in accordance

with sections 550.0251(6) and 551.112, along with any other remedy provided by chapters 550

and 551, Florida Statutes, and/or the rules promulgated thereunder.

APPENDIX A

28-106.2015 Agency Enforcement and Disciplinary Actions.

- (1) Prior to entry of a final order to suspend, revoke, or withdraw a license, to impose administrative fines, or to take other enforcement or disciplinary action against a licensee or person or entity subject to the agency's jurisdiction, the agency shall serve upon the licensee an administrative complaint. For purposes of this rule, an agency pleading or communication that seeks to exercise an agency's enforcement authority and to take any kind of disciplinary action against a licensee or other person shall be deemed an administrative complaint.
- (2) An agency issuing an administrative complaint shall be the petitioner, and the licensee against whom the agency seeks to take disciplinary action shall be the respondent.
- (3) The agency's administrative complaint shall be considered the petition, and service of the administrative complaint on the respondent shall be deemed the initiation of proceedings.
 - (4) The agency's administrative complaint shall contain:
- (a) The name of the agency, the respondent or respondents against whom disciplinary action is sought and a file number.
- (b) The statutory section(s), rule(s) of the Florida Administrative Code, or the agency order alleged to have been violated.
 - (c) The facts or conduct relied on to establish the violation.
- (d) A statement that the respondent has the right to request a hearing to be conducted in accordance with Sections 120.569 and 120.57, F.S., and to be represented by counsel or other qualified representative.
 - (5) Requests for hearing filed by the respondent in accordance with this rule shall include:
- (a) The name, address, any e-mail address, telephone number, and facsimile number, if any, of the respondent, if the respondent is not represented by an attorney or qualified representative.
- (b) The name, address, e-mail address, telephone number, and facsimile number of the attorney or qualified representative of the respondent, if any, upon whom service of pleadings and other papers shall be made.
- (c) A statement requesting an administrative hearing identifying those material facts that are in dispute. If there are none, the petition must so indicate.
 - (d) A statement of when the respondent received notice of the administrative complaint.
 - (e) A statement including the file number to the administrative complaint.
