**FINAL ORDER APPROVING AMENDMENT TO CARDROOM LICENSE**

Pursuant to the provisions of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications and amendments to applications for cardrooms; and

Daytona Beach Kennel Club, Inc. d/b/a Daytona Beach Racing and Card Club and/or Daytona Beach Kennel Club & Poker Room (“Daytona”) possesses a greyhound permit. Daytona has been issued a pari-mutuel operating license and a cardroom license for the 2022-2023 Fiscal Year. Daytona currently has 46 card tables and is requesting permission to add 12 more to its cardroom. Daytona has paid the \$12,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Daytona’s amended application for a cardroom license and after proper consideration thereof,

**NOW, THEREFORE**, be it known that:

Pursuant to the requirements of section 849.086, Florida Statutes, the Commission hereby approves this amendment to Daytona Beach Kennel Club, Inc.’s cardroom license.

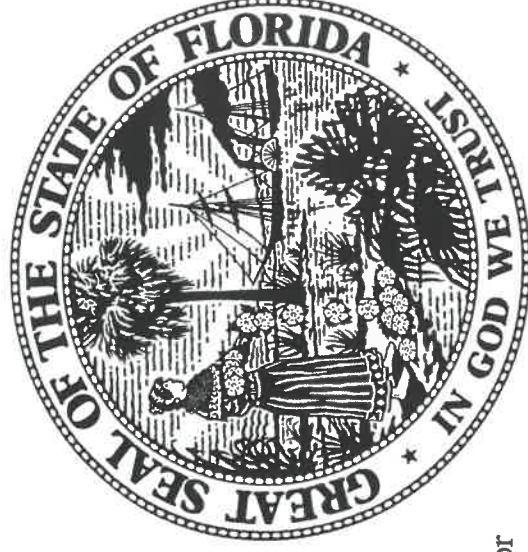
