FINAL ORDER APPROVING AMENDMENT TO CARDROOM LICENSE

Pursuant to the provisions of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for cardrooms; and

Sarasota Kennel Club, Inc. d/b/a One-Eyed Jack's Poker Room ("Sarasota") possesses a greyhound permit. Sarasota has been issued a pari-mutuel operating license and a cardroom license for the 2022-2023 Fiscal Year. Sarasota currently has 30 card tables and is requesting permission to add 2 more to its cardroom. Sarasota has paid the \$2,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Sarasota Kennel Club, Inc., amended application for a cardroom license and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Commission hereby approves this amendment to Sarasota Kennel Club, Inc.'s cardroom license.


NOTICE OF RIGHT TO JUDICIAL REVIEW

SUCH PROCEEDINGS ARE COMMENCED BY FILING ONE COPY OF A NOTICE OF APPEAL WITH THE CLERK OF THE FLORIDA GAMING CONTROL COMMISSION AND A SECOND COPY, ACCOMPANIED BY FILING FEES PRESCRIBED BY LAW, WITH THE DISTRICT COURT OF APPEAL OF THE FIRST DISTRICT OR IN THE APPELLATE DISTRICT WHERE THE PARTY RESIDES. THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


