**FINAL ORDER APPROVING AMENDMENT TO PARI-MUTUEL OPERATING
LICENSE**

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

Gulfstream Park Racing Association, Inc. d/b/a Gulfstream Park Racing and Casino ("Gulfstream") possesses a valid thoroughbred permit. Gulfstream has been issued a pari-mutuel operating license for the 2022-2023 Fiscal Year. Gulfstream's current license, Amendment B, included 162 performances (157 regular and 5 charity). Now, Gulfstream wants to amend its operating license by canceling all Thursday performances in October and adding five performances in December for a total of 163 performances (158 regular and 5 charity).

The Commission has received and reviewed the pertinent records and supporting documentation concerning Gulfstream Park's amended application for a pari-mutuel operating license and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Commission hereby approves this amendment to Gulfstream Park Racing Association, Inc.'s pari-mutuel operating license.


