**FINAL ORDER APPROVING AMENDMENT TO PARI-MUTUEL OPERATING
LICENSE**

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

Gulfstream Park Thoroughbred After Racing Program, Inc. (“GPTARP”) possesses a valid thoroughbred permit. GPTARP has been issued a pari-mutuel operating license for the 2022-2023 Fiscal Year. GPTARP’s current license, includes 42 performances (37 matinee and 5 charity). Now, GPTARP wants to amend its operating license by canceling two thoroughbred performances resulting in a new total of 40 performances (35 regular and 5 charity).

The Commission has received and reviewed the pertinent records and supporting documentation concerning Gulfstream Park's amended application for a pari-mutuel operating license and after proper consideration thereof,


NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Commission hereby approves this amendment to Gulfstream Park Thoroughbred After Racing Program, Inc. pari-mutuel operating license. This Final Order is issued *nunc pro tunc* to June 1, 2023.

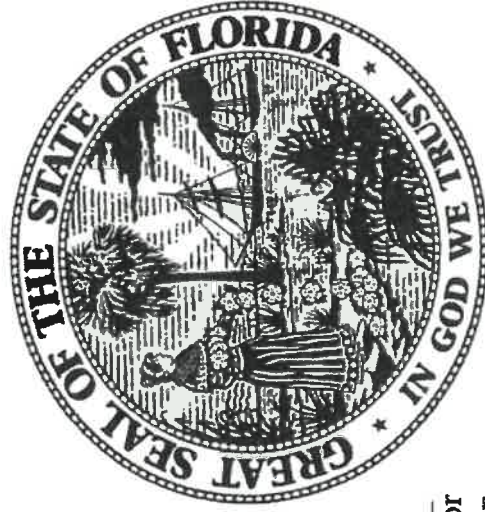
