FINAL ORDER APPROVING SLOT MACHINE LICENSE RENEWAL

Pursuant to the provisions of section 551.103, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications for slot machine license renewals; and

831 Federal Highway Acquisition, LLC d/b/a The Big Easy Casino (“Big Easy”) is located in Broward County. Slot machine gaming is authorized in Miami-Dade and Broward Counties. Big Easy possesses a valid greyhound permit and has been issued a pari-mutuel operating license and cardroom license for both the 2022-2023 Fiscal Year and the 2023-2024 Fiscal Year. Big Easy has submitted a complete renewal application for a slot machine license and has paid the application fee.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Big Easy’s renewal application for a slot machine license and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 551.103, Florida Statutes, the Commission hereby approves 831 Federal Highway Acquisition, LLC d/b/a The Big Easy Casino’s slot machine license renewal.

FLORIDA LICENSE FOR SLOT MACHINE OPERATIONS

WHEREAS 831 Federal Highway Acquisition, LLC d/b/a The Big Easy Casino is the holder of a valid active greyhound pari-mutuel permit at its facility located in Broward County, granted pursuant to Chapter 550, Florida Statutes.

WHEREAS The Big Easy Casino is authorized to conduct Pari-Mutuel Wagering activities at its facility pursuant to the Laws of Florida, on approved dates.

WHEREAS the majority of voters of Broward County, Florida, authorized slot machines at pari-mutuel facilities within Broward County in a county-wide referendum conducted March 8, 2005.

WHEREAS The Big Easy Casino has made application for licensure to conduct Slot Machine Gaming from June 11, 2023, through June 10, 2024, pursuant to Florida Statutes and Administrative Rules adopted pursuant thereto. It has been found that The Big Easy Casino has fulfilled all the statutorily required conditions for licensure and is, therefore, qualified to hold a license to conduct Slot Machine Gaming as authorized under the Laws of Florida.

WHEREAS The Big Easy Casino has furnished and shall maintain in effect during the term of this license, the appropriate bond as required under Chapter 551, Florida Statutes.

NOW THEREFORE BE IT KNOWN that The Big Easy Casino is granted a non-transferable license, Number **SM144**, under which The Big Easy Casino may, exclusively at the slot machine facility located at 831 Federal Highway Acquisition, LLC, at 831 North Federal Highway, Hallandale Beach, Florida 33009, receive, possess, operate and ship approved slot machine equipment, and conduct Slot Machine Gaming.

BY RECEIVING THIS LICENSE The Big Easy Casino agrees to, at all times during the term of this license, conduct its Slot Machine Gaming operation and maintain its Slot Machine Gaming facility in accordance with applicable Florida Statutes and Administrative Rules adopted pursuant thereto.
