FINAL ORDER APPROVING AMENDMENT TO CARDROOM LICENSE

Pursuant to the provisions of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications and amendments to applications for cardrooms; and

West Volusia Racing, Inc. d/b/a Orange City Racing and Card Club (“Orange City”) possesses a greyhound permit. Orange City has been issued a pari-mutuel wagering operating license and a cardroom license for the 2024-2025 Fiscal Year. Orange City is currently licensed to operate 40 card tables and is requesting permission to add 18 card tables to its cardroom. Orange City has paid the \$18,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Orange City’s amended application for a cardroom license and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 849.086, Florida Statutes, the Commission hereby approves this amendment to West Volusia Racing, Inc.’s cardroom license.


