FINAL ORDER APPROVING AMENDMENT TO CARDROOM LICENSE

Pursuant to the provisions of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications and amendments to applications for cardrooms; and

Dania Entertainment Center, LLC d/b/a Dania Jai-Alai and/or The Casino @ Dania Beach (“Dania”) possesses a jai alai permit, number 274. Dania has been issued a pari-mutuel wagering operating license and a cardroom license for the 2024-2025 Fiscal Year. Dania is currently licensed to operate 25 card tables and is requesting permission to add 5 card tables to its cardroom. Dania has paid the \$5,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Dania’s amended application for a cardroom license and after proper consideration thereof,


NOW, THEREFORE, be it known that:


NOTICE OF RIGHT TO JUDICIAL REVIEW

THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.


