FINAL ORDER APPROVING AMENDMENT TO
PARI-MUTUEL OPERATING LICENSE

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

West Flagler Associates, Ltd., d/b/a Summer Jai-Alai, possesses a valid jai-alai permit, permit number 280. Summer Jai Alai was issued a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year. Summer Jai Alai's 2024-2025 operating license included 11 performances. Summer Jai Alai has applied for an amended operating license, canceling all Sunday performances previously scheduled in April 2025 and adding two performances on April 9th and April 16th for a total of 10 performances.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Summer Jai Alai's amended application for a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year, and after proper consideration thereof,


NOW, THEREFORE, be it known that:

In accordance with section 550.01215, Florida Statutes, the Commission hereby approves this amendment to West Flagler Associates, LTD., d/b/a Summer Jai Alai pari-mutuel wagering operating license.


NOTICE OF RIGHT TO JUDICIAL REVIEW

THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
