**FINAL ORDER APPROVING AMENDMENT TO
PARI-MUTUEL OPERATING LICENSE**

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

Gulfstream Park Racing Association, Inc., d/b/a Gulfstream Park Racing and Casino possesses a valid thoroughbred permit, number 321. Gulfstream was issued a pari-mutuel license for the 2024-2025 fiscal year. The current license includes 160 performances (155 matinees and 5 charity). Now, Gulfstream wants to amend its operating license, moving its December 28th charity thoroughbred performance to December 21st.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Gulfstream’s amended application for a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year, and after proper consideration thereof,

NOW, THEREFORE, be it known that:

In accordance with section 550.01215, Florida Statutes, the Commission hereby approves this amendment to Gulfstream Park Racing Association, Inc., d/b/a/ Gulfstream Park Racing and Casino’s pari-mutuel wagering operating license.

This final order is issued Nunc pro tunc to December 20, 2024. It is so ordered.
