



FLORIDA LICENSE FOR SLOT MACHINE OPERATIONS

WHEREAS Gulfstream Park Racing Association, Inc. d/b/a Gulfstream Park Racing & Casino is the holder of a valid, active permit to conduct thoroughbred racing at its facility located in Broward County, granted pursuant to Chapter 550, Florida Statutes.

WHEREAS Gulfstream Park Racing Association, Inc. is authorized to conduct Pari-Mutuel Wagering activities at its facility pursuant to the Laws of Florida, on approved dates.

WHEREAS the majority of voters of Broward County, Florida, authorized slot machines at pari-mutuel facilities within Broward County in a county-wide referendum conducted March 8, 2005.

WHEREAS Gulfstream Park Racing Association, Inc. has made application for licensure to conduct Slot Machine Gaming from October 13, 2024, through October 12, 2025, pursuant to Florida Statutes and Administrative Rules adopted pursuant thereto. It has been found that Gulfstream Park Racing Association, Inc. has fulfilled all the statutorily required conditions for licensure and is, therefore, qualified to hold a license to conduct Slot Machine Gaming as authorized under the Laws of Florida.

WHEREAS Gulfstream Park Racing Association, Inc. has furnished and shall maintain in effect during the term of this license, the appropriate bond as required under Chapter 551, Florida Statutes.

NOW THEREFORE BE IT KNOWN that Gulfstream Park Racing Association, Inc. is granted a non-transferable license, Number **SM321**, under which Gulfstream Park Racing Association, Inc. may, exclusively at the slot machine facility located at 901 South Federal Highway, Hallandale Beach, Florida 33009, receive, possess, operate and ship approved slot machine equipment, and conduct Slot Machine Gaming.

BY RECEIVING THIS LICENSE Gulfstream Park Racing Association, Inc. agrees to, at all times during the term of this license, conduct its Slot Machine Gaming operation and maintain its Slot Machine Gaming facility in accordance with applicable Florida Statutes and Administrative Rules adopted pursuant thereto.

Pursuant to the provisions of section 551.103, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications for slot machine license renewals; and

Gulfstream Park Racing Association, Inc. d/b/a Gulfstream Park Racing & Casino ("Gulfstream") is located in Broward County, permit number 321. Slot machine gaming is authorized in Miami-Dade and Broward Counties at certain pari-mutuel facilities. Gulfstream possesses a valid thoroughbred permit and has been issued a pari-mutuel operating license for the 2024-2025 Fiscal Year. Gulfstream has submitted a complete renewal application for a slot machine license and has paid the application fee.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Gulfstream's renewal application for a slot machine license and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 551.103, Florida Statutes, the Commission hereby approves Gulfstream's slot machine license renewal.
