PPI, Inc. D/B/A Harrah's Pompano Beach ("PPI") possesses a harness permit. PPI has been issued a pari-mutuel operating license and a cardroom license for the 2024-2025 Fiscal Year. PPI is currently licensed to operate 60 card tables and is requesting permission to add two more to its cardroom. PPI has paid the \$2,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning PPI amended application for a cardroom license and after proper consideration thereof,


NOW, THEREFORE, be it known that:


NOTICE OF RIGHT TO JUDICIAL REVIEW

THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
