**FINAL ORDER APPROVING AMENDMENT TO  
PARI-MUTUEL WAGERING OPERATING LICENSE**

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission (“Commission”) is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

RB Jai Alai LLC d/b/a Orlando Live Events (“RB Jai Alai”) possesses a valid jai-alai permit, permit number 270. RB Jai Alai has been issued a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year. RB Jai Alai’s 2024-2025 operating license includes 40 performances (35 matinee and 5 charity). RB Jai Alai has applied for an amended operating license canceling 35 matinee and 5 charity performances from July 22, 2024, to July 26, 2024, and adding 35 matinee and 1 charity performances from September 23, 2024, to September 27, 2024, resulting in a new schedule of 36 performances (35 matinee and 1 charity).

The Commission has received and reviewed the pertinent records and supporting documentation concerning RB Jai Alai’s amended application for a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year and after proper consideration thereof,

**NOW, THEREFORE**, be it known that:




NOTICE OF RIGHT TO JUDICIAL REVIEW

THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
